WHEREAS, the permission was granted to the institution namely AMAR BHARTIYA MAHAVIDYALAYA, CHAUHAN, PYAU, THATIPUR, GWALIOR- 474011, MADHYA PRADESH for conducting D.Ed. course additional unit vide order No.WRC/5-6/105th/2008/39744-39749 dated 25.08.2008.

AND WHEREAS, the inspection of the said institution was conducted u/s 17 on 18.11.2009. The report of the visiting team was considered by WRC in its 128th Meeting held from November 29-30, 2009 and it was decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued on 28.12.2009.

AND WHEREAS, the institution has not submitted any reply/representation. The matter was placed before WRC in its 130th meeting held from January 22-23, 2010 and it was decided that recognition for D.Ed. & D.Ed. additional intake be withdrawn from the end of the academic session next following the date of withdrawal order. Accordingly, withdrawal order was issued to the institution on 23.03.2010.

AND WHEREAS, the institution had preferred an appeal under Section 18 of the NCTE Act 1993, before the Council against the aforesaid order and the Appellate Authority vide order dated 19.07.2010 rejected the appeal and confirmed WRC's order dated 23.03.2010.

AND WHEREAS, the institution thereafter filed W.P. No. 4530/2010 in the Hon'ble High Court of M.P. Bench at Gwalior. The Hon'ble Court disposed of the W.P. vide order dated 15.11.2010.

AND WHEREAS, the NCTE has filed an SLP No. 21906/2011 in the Hon'ble Supreme Court of India against the decision of the Hon'ble High Court in W.P. No.4530/2010. The Hon'ble Court passed an order dated 12.04.2012.

AND WHEREAS, the Inspection of the institution was conducted by NCTE Hqrs u/s 13 on 23.05.2012 and deficiency letter issued to the institution on 01.08.2012.

AND WHEREAS, the reply submitted by the institution on 28.08.2012 was placed before WRC in its 177th meeting held from January 7-8, 2013 and the Committee decided that clarification be sought from the institution. Accordingly, clarification letter was issued to the institution on 06.02.2013.

AND WHEREAS, the reply submitted by the institution on 06.03.2013 was placed before WRC in its 185th meeting held from June 13-15, 2013 and the Committee decided that Show Cause Notice be issued to the institution. Accordingly, Show Cause Notice was issued to the institution on 24.06.2013.

AND WHEREAS, the reply submitted by the institution on 31.07.2013 was placed before WRC in its 189th meeting held from August 29-31, 2013 and the Committee observed that "in this case, two courses D.Ed. and D.Ed. additional were Withdrawn vide order dated 23.03.2010. Thereafter, the institution has approached the Hon'ble Supreme Court. The NCTE has filed an SLP in the Hon'ble Supreme Court. Under the orders of the Hon'ble Supreme Court, the NCTE got the institution inspected u/s 13 of the NCTE Act on 23.05.2012 and then deficiency letter dated 01.08.2012 was issued. Clarification was sought from the institution vide letter dated 06.02.2013 on the grounds for submission of formal application for shifting or premises, fees, duly approved staff list, affidavits of management and staff and CLU. In the 185th meeting, the institution had submitted formal application for shifting and processing fee. However, the institution had not filled-up the faculty posts as required under the NCTE Regulations, 2009 for two units of D.Ed. course. Show Cause Notice was issued to the institution on 24.06.2013 on these grounds mentioning as to why the withdrawal order dated 23.03.2010 should not continue to stand. Hence, in response to the Show Cause Notice dated 24.06.2013, the institution has submitted approved staff profile according to which the Lecturer in Physical Education and lecturer in fine arts have been appointed. Hence, Recognition is restored and shifting is permitted.
