Recognition Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 ASHOKA D.S. COLLEGE, KHASRA NO. 610 VILLAGE- AMBHA., POOTH ROAD, TEL- AMBHA, DIST MORENA, - 476001 MADHYA PRADESH has submitted an application (Code No. AFW06349/222344) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting D.ED. (CO.ED) course with an annual intake of 50 students on 23-06-2007

AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the effort and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the FLE teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to ASHOKA D.S. COLLEGE, KHASRA NO. 610 VILLAGE- AMBHA., POOTH ROAD, TEL- AMBHA, DIST MORENA, - 476001 MADHYA PRADESH for conducting D.ED. (CO.ED) (II) course from academic session 2009-2010 of FLE of 2 year duration with an annual intake of 50 student under clause 7(1) of NCTE Recognition Norms & Procedures Regulation 2009.

4. The admission of student shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of student shall be completed well before the cut off date prescribed by the examining body from the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011.


5. The recognition/ permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University /Affiliating Body.

The institution shall, within one month of the receipt of recognition order, convert the endowment fund and the fund account into a joint account to be operated along with an officer of the Western Regional Committee.

The institution shall comply with the various other norms and standards prescribed in the NCTE regulations as and when the time to time.


The institution shall ensure that the required number of students are admitted in the first year of the course of study as per the provision of the NCTE Recognition Norms & Procedures Regulation 2009.





10. Further, subject to the provision of NCTE Act 1993 The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. applicable

11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information for having fulfilled the norms & standard and other required conditions.

13. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulation and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

14. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.

Refusal Order

WHEREAS, ASHOKA D.S. COLLEGE, SHRI MEGH SINGH BAL VIKAS & S.PRASAR SAMITTI, C/O- VISHAL SINGH SIKARWAR, GOPAL PURA, TOMARGALI, BANKHANDI ROAD, MORENA - 476001, MADHYA PRADESH Code No. (APW06349/222344) had applied for grant of recognition/permission for D.E.D. (CO.ED)(H) in ELN Course of 2-year(s) duration under Section 14 of the NCTE Act, 1993 to the WRC, NCTE on 6/23/2007.

2. AND WHEREAS the inspection of the institution was conducted on 20/02/08 by a visiting team.

3. AND WHEREAS in its 121st meeting held on Jul.8-9-2009 the Western Regional Committee after considering the report of the visiting team, perusal of videography as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on 02/09/08 (105th) to the applicant institution under provision to Section 14 (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

4. AND WHEREAS the applicant institution had not submitted any representation to WRC, NCTE. The said representation of the institution as well as videography were again duly considered by the Western Regional Committee on Jul. 8-9-2009, which came to the conclusion that recognition/permission to the said institution be refused for the following reasons.

1. Reply of clarification not received within stipulated time.

5. NOW, THEREFORE grant of recognition/permission to ASHOKA D.S. COLLEGE, SHRI MEGH SINGH BAL VIKAS & S PRASAR SAMITTI for conducting the D.E.D. (CO.ED)(H) course in terms of section 14(3) of the NCTE Act, 1993, is hereby refused.
