उपरोक्त संदर्भित पत्रांतर्गत अवगत कराया जाता है कि वादि संस्था (Petitioner Institution) B.P. DIXIT B.ED. COLLEGE, S.D. TIWARI EDUCATION DEVELOPMENT COMMITTEE, AWASTHI BUNGLOW, DAFFODIL SCHOOL NOWGANG, CHHATARPUR, MADHYA PRADESH द्वारा मध्य प्रदेश उच्च न्यायालय, जबलपुर में एक याचिका क्रमांक 8054/2014 दायर की गई थी, जिसका उच्च न्यायालय द्वारा दिनांक 12/06/2014 को एक आदेश पारित किया गया था जो निम्नलिखित है।

*"In view of the aforesaid submissions made by learned counsel for parties and for the reasons assigned by a Bench of this Court in order dated 05.04.2014, the impugned\* order dated 27.03.2014 communicated to the petitioner on 02.05.2014 is hereby quashed. The respondents No.1 and 2 would be at liberty to take action against the petitioner, if so advised, in accordance with law. Needless to state, that till the fresh action is taken against the petitioner it shall have right to take benefit of recognition which was available to it. Accordingly, the Writ Petition is disposed of."*

WHEREAS in terms of Section Section 15(1) of the NCTE Act, 1993 B.P. DIXIT B.ED. COLLEGE, RUN BY SHAMBHU DAYAL SHIKSHA PRASAR SAMITI NOWGONG-CHHTARPUR, MADHYA PRADESH has submitted an application (Code No. APW04116/223427 (ADDL)) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting B.ED.(CO.ED)(ADDL) course with an annual intake of 100 students on 7-12-2006

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee observed that the institution/society was not fulfilling the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the SEC teacher education programme. So committee refuse recognition in its 102<sup>nd</sup> Meeting and insitution was informed vide letter no APW04116/223427 (ADDL) /102/2008/35376 date 25.03.2008.

3. Institution submitted an appeal to appellate authority against the order no APW04116/223427 (ADDL) /102/2008/35376 date 25.03.2008. and appellate authority reversed the order of Regional Committee vide order no. F.No.89-232/2008-Appeal dated 14.10.08.

4. NOW, THEREFORE, in exercise of the powers vested under Section 15(1) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to B.P. DIXIT B.ED. COLLEGE, RUN BY SHAMBHU DAYAL SHIKSHA PRASAR SAMITI NOWGONG-CHHTARPUR, MADHYA PRADESH for conducting B.ED.(CO.ED)(ADDL) course of SEC of I year duration with an annual intake of 100 under clause 7(1) of NCTE (Recognition Norms & Procedure) Regulation 2007. With this the total approved for the B.ED.(CO.ED)(ADDL) course to the institution B.P. DIXIT B.ED. COLLEGE, RUN BY SHAMBHU DAYAL SHIKSHA PRASAR SAMITI NOWGONG-CHHTARPUR, MADHYA PRADESH becomes 200 (SECONDARY).

5. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

6. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

7. The institution shall make admission only after it obtains affiliation from the examining body in accordance with clause 8(1) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

- 8. The institution shall ensure that the required number of academic staff for conducting the course is always in-position.
- 9. Further, subject to the provision of NCTE Act, 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. applicable.
- 10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:
  - (i) Copy of the Application Form
  - (ii) Land and Building Particulars.
  - (iii) Staff Profile.
  - (iv) Recognition letter.
  - (v) Information for having fulfilled the norms & standard and other required conditions.
- 12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

**Revised Order**

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the **B.P. DIXIT B.ED. COLLEGE RUN BY- SHAMBHU DAYAL SHIKSHA PRASAR SAMITI, NOWGONG, CHHATARPUR, MADHYA PRADESH** by affidavit date 20.01.2015 has consented to come under new Regulations and sought for four basic units in **B.Ed**, which require additional facilities.

3. And whereas, it has been decided to permit the institution to have four basic units of 50 students each subject to the institution fulfilling following conditions namely:-

I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.

III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the **NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to B.P. DIXIT B.ED. COLLEGE RUN BY- SHAMBHU DAYAL SHIKSHA PRASAR SAMITI, NOWGONG, CHHATARPUR, MADHYA PRADESH for conducting B.Ed programme of two years duration with an annual intake of 200 students (four basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.**

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- Sanctioned programmes along with annual intake in the institution;
- Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- Name of faculty members who left or joined during the last, quarter;
- Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- Fee charged from students;
- Available infrastructural facilities;
- Facilities added during the last quarter;
- Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information. If it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order Dated 31.08.2006, 01.12.2008 be treated as cancelled from the date of issue of this revised order.
