Sir/Madam,

With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order No. WRC/APW05303/225072/{M.P.}2015/147714-147721 dt. 31.05.2015 was issued to the institution for conducting M.Ed. programme of two year duration with an annual intake of 50 students (One basic unit) from the academic session 2015-2016.

The WRC in its 297<sup>th</sup> meeting held on September 13-14, 2018 considered the reply dt. 25.01.2017 received in WRO on 09.02.2017 submitted by the institution, for compliance of conditions as mentioned in the revised recognition order dt. 31.05.2015 and the Committee decided that:

"...Consequent to the issue of Revised Recognition order, Show Cause Notice dated 13.01.2017 was issued The institution replied on 09.02.2017 and has submitted a staff profile of 10 faculty members approved by the Registrar. Hence, permitted to continue."

**Therefore, it is informed that the institution is permitted to continue the M.Ed. course of two year duration with an annual intake of 50 students from the session 2018-19.**

It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulation, 2014.

Terms and conditions mentioned in the revised order (vide order no. WRC/APW05303/225072/{M.P.}2015/147714-147721 dt. 31.05.2015) will remain unchanged.
