Sir/Madam,

With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/APW04053/323397 (addl.)/323088/2015/141735 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two years duration with an annual intake of 200 seats (four basic units of 50 students) from session 2015-2016.

- 2. And whereas, non-receipt of documents mentioned revised recognition order from the institution a show cause notice dt. 30.08.2016 was issued to the institution.
- 3. And whereas, the WRC in its 283<sup>rd</sup> meeting held on November 14<sup>th</sup>-15<sup>th</sup>, 2017 considered the reply dt. 27.09.2016 submitted by the institution, in response to SCN letter dt. 30.08.2016 and decided as follows:-

"The case file was seen. As per Revised Recognition order, the institution has submitted documents as required. However, the staff profile approved by the affiliating body should be submitted in original. Building Completion Certificate signed by a Govt. Engineer should be submitted in original.

Compliance should be submitted by the institution within one month, failing which action will be initiated as per NCTE Regulations, 2014."

- 4. And Whereas, a conveyed letter no. WRC/APW04053/323397/B.Ed./283<sup>rd</sup>/Guj/2017/193162 dt. 21.11.2017 was issued to the institution for submitted the documents.
- 5. And Whereas, reply dt. 13.12.2017 submitted by the institution was placed before the WRC in its 291st meeting held on April 26<sup>th</sup> 27<sup>th</sup>, 2018 considered the documents and committee decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 30.08.2016 followed by a compliance letter dated 21.11.2017 were issued. The institution was asked to submit the staff profile approved by the Registrar. As per the current staff list, the institution is eligible for one unit. If more staff is appointed as per Appendix-IV of NCTE Regulations, 2014 and subsequent NCTE notification published on 09.06.2017, additional units can be considered.

Hence, clarification be sought from the institution. Reply should be submitted within one month failing which recognition will be reduced to one unit."

6. And Whereas, a conveyed letter no. WRC/APW04053/323397/B.Ed./291<sup>st</sup>/Guj/2018/197475 dt. 04.05.2018 was issued to the institution for submitting the documents.

7. And Whereas, reply dt. 06.07.2018, 04.12.2018 & 10.01.2019 submitted by the institution was place before the WRC in its  $301^{st}$  meeting held on January  $17^{th}$ – $18^{th}$ , 2019. The Committee considered the documents and decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 30.08.2016 followed by a Compliance letter dated 21.11.2017 & 04.05.2018 were issued.

The institution in its reply dated 06.07.2018, 04.12.2018 & 10.01.2019 has submitted a staff profile in original. Building Completion Certificate and FDRs for Rs. 12.00 lakhs submitted.

### Hence, permitted to continue for two units."

- 8. Therefore, the <u>recognition to the institution is permitted to continue the existing B.Ed. course of two years duration with an annual intake of 100 seats (two basic units of 50 students each), from session 2019-2020.</u>
- 9. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
