

RESTORATION ORDER

Whereas, recognition was granted to the institution, namely, Shree Saraswati Shikshan Mahavidyalaya (M.Ed. College), (Run by Vidya Bharti Gujarat Pardesh Salang, Late Ratilal Vaghasiya Smarak Trust), Dhoraji, Rajkot Gujarat-360410 under section 15 of NCTE Act, 1993 for conducting M.Ed. course with an annual intake of 25 students vide order no. WRC/5-6/102nd/2008/30501 dated 14.03.2008.

2. And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Shree Saraswati Shikshan Mahavidyalaya (M.Ed. College), (Run by Vidya Bharti Gujarat Pardesh Salang, Late Ratilal Vaghasiya Smarak Trust), Dhoraji, Rajkot Gujarat-360410 offering M.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

3. And whereas, after the receipt of affidavit dt. 12.01.2015 from the institution, a revised recognition order no. WRC/APW04043/325044/2015/148437-444 dt. 31.05.2015 was issued to the institution for conducting M.Ed. Programme of two years duration with an annual intake of 50 seats (one basic unit of 50 students) from session 2015-16.

4. And Whereas, the matter was placed before the WRC in its 276th Meeting held on May 30th-31st, 2017 and the Committee decided to issue show cause notice dt. 14.07.2017.

5. And whereas, reply dt. 21.09.2017 was placed before the WRC in its 282nd meeting held on October 24-26, 2017 and the Committee decided as follows :-

"The case file was seen. Show Cause Notice was issued to the institution on 14.07.2017 regarding staff, Building Completion Certificate, FDRs and CLU. The institution replied on 21.09.2017. While most of the conditions has been fulfilled, it has submitted a list of only five faculty duly approved by the competent authority. Therefore, the institution does not fulfill the requirement of two Professors, two Associate Professors, and six Assistant Professors, as per Appendix-V of NCTE Regulations, 2014.

Hence, Recognition is withdrawn from the session 2018-2019"

6. And Whereas, a withdrawal order no. WRC/APW04043/325044/Guj./282nd/2017/192459-2466 dt. 02.11.2017 was issued to the institution.

7. And Whereas, the institution has filed an appeal at NCTE Hqrs. New Delhi and the Appellant Authority vide order dt. 12.09.2018 has decided as follows:-

"After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to the WRC for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously

The Council hereby remands back the case of Shree Saraswati Shikshan Mahavidyalay, (M.Ed. College), Bhutvad, Dhoraji - Jetpur Highway, Near Bhutvad Patiya, Gujarat to the WRC, NCTE, for necessary action as indicated above."

8. And Whereas, reply dt. 24.09.2018 of institution was placed before the WRC in its 299th meeting held on October, 30 - November 1, 2018, and Committee decided as follows:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

On perusal of the reply dated 24.09.2018, the Committee observed that:-

- (i) The institution has submitted the approved staff list of 1+9 faculty members. But the staff list are not as per Appendix-5 of NCTE Regulations, 2014, which require two Professors, two Associate Professors and six Assistant Professors.
- (ii) The faculty members mentioned in the list submitted for M.Ed. course at S.No.5 and the faculty members mentioned in the list submitted for B.Ed. course at S.No.4 are same.
- (iii) Building Completion Certificate duly signed by competent authority not submitted.
- (iv) FDR for Rs.12.00 lakhs in original as required under clause 10(1) of NCTE Regulations, 2014 submitted.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

9. And Whereas, show cause notice no. WRC/APW04043/325044/299th/M.Ed./Guj./2018/200597 dt. 15.11.2018 was issued to the institution.

10. And Whereas, reply dt. 03.12.2018 & 04.12.2018 of institution was placed before the WRC in its 300th meeting held on December 17-18, 2018, and Committee decided as follows:-

"The case file was seen. Show Cause Notice was issued to the institution on 15.11.2018. The institution replied on 04.12.2018 and an examination of the file shows that the staff, building and FDRs are in order as per the NCTE Regulations, 2014.

Therefore, Recognition for the M.Ed. course is restored."

11. And Whereas, matter of the institution was again placed before the WRC in its 301st meeting held on January 17-18, 2019, as its file for B.Ed. course (APW04053/323397) was deferred in the 300th meeting and the Committee decided as follows:-

"APW04053/323397 - B.Ed. course - Due to deferment of B.Ed. course in the 300th meeting, the decision for M.Ed. course in the file No.325044 of Restoration could not be issued."

12. Now Therefore, this restoration order is issued as per decision of the WRC in its 300th meeting as cited above.

13. It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
