ORDER

Whereas, recognition was granted to the institution, namely, Shri Kanwartara Institute For Teachers Training, Shrinagar Extension, Po - Gram Mardania, Mandleshwar, Teshil - Maheshwar, Khargone, Madhya Pradesh (APW03556/223477) for B.Ed. Course for 100 Intake vide order dated 31.08.2006.

- 2. AND WHEREAS, the letter for Affidavit Regarding Acceptance And Compliance Of Ncte Regulations, 2014 was issued to the institution on 19.01.2015 and the reply was received on 30.01.2015.
- 3. AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 27.05.2015.
- 4. AND WHEREAS, the standing decision of WRC taken in the 255<sup>th</sup> meeting held on 22-24 June, 2016 regarding issue of SCN to all cases who have not complied NCTE Regulation 2014 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses. The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item."
- 5. AND WHEREAS, the Compliance Show Cause Notice was issued to the institution on 19.09.2016 and the reply of SCN was received on 25.10.2016.
- 6. AND WHEREAS, the matter was placed in 285<sup>th</sup> Meeting held on December 19<sup>th</sup> -21<sup>st</sup>, 2017 of WRC and the Committee decided that "...In response to the Show Cause Notice dated 23.05.2016, the institution vide letter dated 22.06.2017 has submitted staff list which is neither in the prescribed format nor approved by the affiliating University.

The institution is required to submit a list of 1+15 faculty in the NCTE format duly approved by the Registrar for the current academic year in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

## Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- 7. AND WHEREAS, the Clarification letter was issued to the institution on 29.12.2017 and the reply of Clarification was received on 09.02.2018.
- 8. AND WHEREAS, the matter was placed in 296<sup>th</sup> Meeting held on August 28 -29, 2018 of WRC and the Committee decided that "...Compliance letter was issued to the institution on 29.12.2017 regarding submission of staff list in the prescribed format approved by the Registrar and Building Completion Certificate. The institution replied on 09.02.2018 but has not furnished information as required.

#### Hence, Recognition is withdrawn."

- 9. AND WHEREAS, the withdrawal order was issued to the institution on 07.09.2018. Institution filed a appeal on 17.09.2018 at NCTE, Hqr. Regulatory file sent to H.qrs. on 08.01.2019. Original file received on 26.02.2019 from NCTE HQrs. with Appeal Order dated 18.02.2019.
- 10. AND WHEREAS, Appeal Committee decided that "...after perusal of the Memoranda of appeal, affidavit, documents on record and oral arguments advanced during the hearing, the Committee concluded to remand back case to W.R.C. for revisiting the matter the appellant submits (i) list of faculty approved by affiliating body (ii) B.C.C. and (iii) FDRs within a period of 15 days from the date of issued of Appeal order.

NOW THEREFORE the Council hereby remands back the case of Shri Kanwartara Institute for Teachers Training, Mandleshwar, Shri Nagar Colony, Maheshwar-451221, Madhya Pradesh to the WRC, NCTE, for necessary action as indicated above."

- 11. AND WHEREAS, the reply was submitted by the institution on 06.03.2019 & 20.03.2019.
- 12. AND WHEREAS, the matter was placed of the institution for the B.Ed. course (Code No. APW03556/223477) in 306<sup>th</sup> Meeting held on April 29 -30, 2019 of WRC and the Committee decided that "...The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 31/05/2015. The recognition for B.Ed. course of the Institution was withdrawn vide order dated 07/09/2018. The institution filed an appeal to NCTE Hqrs and appellate authority passed order dated 18/02/2019.

On perusal of the reply of the institution dated 27/02/2019, 16/3/2019, 27/03/2019, 01/04/2019, 10/04/2019, 15/04/2019 & 23/04/2019 along with appeal order dated 18/02/2019 the committee decided to restore the recognition for B.Ed. course of two years duration for two units (100 students) and to issue a formal recognition order accordingly."

- 13. **NOW THEREFORE,** this formal recognition order is issued restoring the recognition of the institution **i.e. Shri Kanwartara Institute For Teachers Training, Shrinagar Extension, PO Gram Mardania, Mandleshwar, Teshil Maheshwar, Khargone, Madhya Pradesh** for B.Ed. course of two year duration with an intake of 100 students (Two basic unit) subject to fulfillment of the following conditions:
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 14. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.
- 15. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:

d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e. Fee charged from students;

f. Available infrastructural facilities;

g. Facilities added during the last quarter;

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.

j. The institution shall be free to post additional relevant information, if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 18. The institution shall make available the list of students admitted on its official website.
- 19. The institution shall fill the information on GIS Portal on the NCTE Website.
- 20. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
