AND, WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution in compliance to the decision of clause 7(13) of the NCTE Regulations, 2014, as amended from time to time the Northern Regional Committee having satisfied itself that the institution fulfils the requirements under the provisions of NCTE Act, Rules and the extant Regulations including the Norms and Standards for the proposed Teacher Education course, such as, instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the course and has selected/appointed qualified teaching staff as per norms duly approved by the affiliating body, decided to grant recognition/ permission to the institution in its **287th meeting held from 18th to 20th July, 2018** for B.Ed. course.

 - An institution, which has been recognised by the Council shall obtain accreditation from an accrediting agency indentified by the Council within five years of the date of recognition.

11. The Institution shall fill the GIS Application within one month from the date of issue of this order.

12. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules and Regulations, the Regional Committee shall withdraw recognition under provisions of Section 17(1) of the NCTE Act, 1993.

13. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
