**Restoration order**

WHEREAS, the institution, namely, **SANT BHAGWAN BABA M.ED. COLLEGE, RUN BY RENUKAMATA KRUSHI VIKAS PRATISHTHAN, PLOT NO.16/3/C.T.S. HOUSE NO.1-6-80/83, SHAHU NAGAR, DIST. BEED, MAHARASHTRA** was granted recognition by WRC NCTE for M.Ed. Course with an annual intake of 25 students vide order No.WRC/5-6/109/208/45567-45572 dated **30.10.2008**.

2. AND WHEREAS, corrigendum issued vide order Q5.11.2008 regarding change of address from SANT BHAGWAN BABA M.Ed. COLLEGE, RUN BY RENUKAMATA KRUSHI VIKAS PRATISHTHAN, PLOT NO. 16/3/C.T.S. HOUSE NO.1-6-80/83, SHAHU NAGAR, DIST. BEED, MAHARASHTRA to SANT BHAGWAN BABA M.ED COLLEGE, RENUKAMATA KRUSHI VIKAS PRATISHTHAN, BEED-PARLI ROAD, KAIJ, MAHARASHTRA.

3. AND WHEREAS, NCTE, New Delhi vide its letter No.F.No.49-4/2010/PT/NCTE (N&S) dated 30.07.2010 had communicated to intimate the institution having approved M.Ed. programme to enhance the existing intake to 35 students from the current session 2010-2011 as notified National Council for Teacher Education Amendment Regulation, 2010 in the Gazette of India on 26<sup>th</sup> July, 2010.

4. AND WHEREAS, permission was granted to the institution vide order dated 23.02.2011 for 35 students in M.Ed. course.

5. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the Revised Recognition Order was issued to the institution vide order No.WRC/APW06344/125127/156662-156668 dated 05.12.2015 for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2015-2016.

6. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255<sup>th</sup> WRC meeting held on June 22-24, 2016, and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 11.11.2016.

7. AND WHEREAS, in response to the aforesaid show cause notice, reply not submitted by the institution.

8. AND WHEREAS, the matter was placed in the 287<sup>th</sup> meeting of WRC held on January 30-31, 2018 and the Committee has decided the following: -

*"The case file was seen. Show Cause Notice was issued to the institution on 11.11.2016 The institution has not replied so far.*

*Hence, Recognition is withdrawn from the session 2018-19. FDRs if any, be returned."*

9. AND WHEREAS, withdrawal order was issued to the institution on 02.02.2018.

10. AND WHEREAS, the institution filed an appeal against the withdrawal order and the Appellate Authority vide order dated 23.12.2019 confirmed the impugned order of withdrawal passed by WRC.

11. AND WHEREAS, the Institution filed a W.P.(C) No.10712/2021 in the Hon'ble High Court of Delhi at New Delhi and the Hon'ble Court has passed an order dated 23.09.2021. The operative part of the order is as under: -

*"...As a result of this order, petitioner's status as a recognised institution continues, until and unless a fresh withdrawal order is passed by the NCTE. As a consequence, the petitioner is entitled to participate in counselling and admit students during such time. The NCTE is directed to issue an order of restoration of recognition within one week. The NCTE will also reflect the status of the petitioner as a recognised institution on its portal and communicate this position to the concerned State Government as well as the affiliating University of the petitioner within the same period."*

12. AND WHEREAS, Restoration Order was issued to the institution on 07.12.2021

13. AND WHEREAS, the Institution filed a W.P.(C) No.11130/2022 in the Hon'ble High Court of Delhi at New Delhi and the Hon'ble Court has passed an order dated 27.07.2022. The operative part of the order is as under: -

*"...6. The limited grievance of the Petitioner is that the afore-noted observation of the WRC can be misinterpreted to mean that the recognition of the Petitioner is only for the session 2021-22, whereas there was no such qualification made in the order dated 23rd September 2021. It has thus filed the instant petition seeking appropriate orders to rectify this mistake."*

*7. It pains the Court to note that this Court is being burdened with such petitions for the clerical mistakes of WRC. Its also quite disturbing to note that WRC does not read and appreciate the orders passed by this Court correctly. The order dated 23rd September, 2021 categorically notes that the recognition of the Petitioner shall continue unless a fresh order is passed by 1 In W.P.(C) 10712/2021 titled Sant Bhagwan Baba M.Ed College vs. National Council For Teacher Education & Anr. NCTE. Despite having made such a unqualified direction, the WRC, while passing the aforesaid restoration order, in terms of the directions given by this Court, mentioned that the Petitioner's recognition is 'restored for the session 2021-22'. This can certainly be misinterpreted and therefore the Petitioner's grievance is justified."*

*8. In view of the above, the present petition is allowed with the following directions:*

*(a) It is clarified that the Petitioner is entitled to admit students for M.Ed. Course for session 2021-22 and also for subsequent sessions unless prohibited by NCTE in accordance with law;*

*(b) WRC shall issue necessary corrigendum regarding the restoration of recognition for the Petitioner and upload the same on their portal;*

*(c) Respondent No. 2-NCTE shall reflect the status of the Petitioner as a recognised institution on its official website and intimate the same to "Dr Babasaheb Ambedkar Marathwada University, Aurangabad, Maharashtra" and to "Education Secretary, [Higher Education] Govt of Maharashtra".*

*9. The copy of this order be also sent to Chairperson and Member Secretary of NCTE, for cautionary instructions to be issued to WRC so that this Court is not further burdened with correcting its clerical mistakes by way of writ petitions.*

*10. With the above directions, the present petition is disposed of."*

14. AND WHEREAS, the matter was placed before WRC in its 370<sup>th</sup> meeting held September 10 & 12, 2022 and the Committee decided as under: -

*"The original file of the Institution along-with other related documents, Order dated 27.07.2022 in W.P.(C) No.11130/2022 passed by Hon'ble High Court of Delhi were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided that in compliance of direction of Hon'ble Court, corrigendum on the WRC's restoration order dated 07.12.2021 be issued. The institution is permitted to participate in the counselling for subsequent academic sessions until a fresh withdrawal order is passed by WRC for admission to M.Ed. course being conducted by the affiliating body/ concerned State Govt. including the previous academic session. The concerned State authorities be intimated accordingly. A copy of restoration order be also uploaded on the WRC web portal on NCTE website.*

*Further, the Committee observed that the institution is still deficient on the following:*

- *The institution is to submit compliance regarding fulfilment of deficiencies pointed out in Show Cause Notice dated 11.11.2016 for consideration by WRC.*

*In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act for M.Ed. programme to submit reply to SCN accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take decision as deemed fit as per the provisions contained in the NCTE Act and Regulations."*

15. NOW THEREFORE, Recognition of **SANT BHAGWAN BABA M.ED COLLEGE, RENUKAMATA KRUSHI VIKAS PRATISHTHAN, BEED-PARLI ROAD, KAIJ, MAHARASHTRA** for conducting M.Ed. programme of two years duration with an annual intake of 50 (one basic unit of 50 students) is hereby restored till a fresh withdrawal order is issued by WRC.

The terms and conditions shall remain same mentioned in the revised recognition order issued vide order dated **05.12.2015**.
