WITHDRAWAL ORDER

WHEREAS, the institution, namely, MAULI COLLEGE OF EDUCATION, BHARAT SHIKSHAN PRASARAK MANDAL, AT. PO.WADALA TAL. NORTH SOLAPUR, DIST. SOLAPUR-413222, MAHARASHTRA was granted recognition by WRC NCTE for BTED B.ED. (CO-ED) Course with an annual intake of 100 students vide order No. WRC/5-6/92/2006 dated 23.01.2007.

- AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised institution vide was issued to the recognition No.WRC/APW02783/123355/2016/143031,036,039,041,044,047,057 dated 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions mentioned in the revised recognition order was placed in 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice u/s 17(1) was issued to the institution dated 05.12.2016.
- AND WHEREAS, institution did not submit reply in response to the show cause notice and the matter was considered by WRC in its 312th meeting held on January 27-29, 2020 and the Committee decided as under:-
 - "On careful perusal of the file of the institution and other related documents, the Committee observed as under:-
 - Revised recognition order was issued to the institution on 31.05.2015 with certain conditions. The compliance to the Revised recognition order was not received.
 - The Show Cause Notice dated 05.12.2016 was issued to the institution on account of non compliance to the revised recognition order.
 - No reply / required documents have been received from the institution."

The Committee resolved to give last opportunity to the institution to submit compliance to the Revised Recognition Order as per NCTE Regulations 2014, as amended vide Notification dated 09th June 2017 within 30 days".

Accordingly, final show cause notice was issued to the institution dated 13.02.2020.

AND WHEREAS, the institution submitted reply vide letter dated 26.02.2020 in response to final show cause notice received in WRC, NCTE on 02.03.2020.

- 6. AND WHEREAS, the institution requested vide letter dated 27.07.2015 followed by another letter dated 03.03.2022 requesting for reduction of B.Ed. intake from 100 to 50 and the matter was considered by WRC in its 359th meeting held on 18th April, 2022. The Committee decided that due to non-submission of resolution of the society regarding reduction of seats from 100 to 50, the request for reduction of B.Ed. intake cannot be processed and the same was communicated to the institution vide letter dated 12.05.2022.
- 7. AND WHEREAS, the matter was considered by the WRC in its 366th meeting held on July 12th and 14th, 2022 and the Committee decided as under: -

"The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

The Committee has also decided to withdraw the recognition of B.Ed. course for on the following ground:

- Show Cause Notice was issued on 05.12.2016
- Final Show Cause Notice was also issued on 13.02.2020
- Reply of Final Show Cause Notice was received on 02.03.2020

The Committee has also decided to withdraw the recognition of B.Ed. course for on the following ground:

- Certified copy of land documents not submitted.
- Approved staff profile as per the NCTE norms/Regulations not submitted
- Originally notarized copy of the building plan submitted.
- Non-encumbrance certificate duly approved by the competent authority not submitted.
- Approved Building Completion Certificate duly signed by the competent authority in the prescribed proforma not submitted.
- Institution has also not uploaded the necessary information on its website.

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act 1993, with effect from the end of the academic session next following the date of communication of the said order."

8. NOW THEREFORE, in exercise of the powers conferred U/S 17 of the NCTE Act, 1993, the recognition granted for B.Ed. course in respect of the institution viz. MAULI COLLEGE OF EDUCATION, BHARAT SHIKSHAN PRASARAK MANDAL, AT. PO.WADALA TAL. NORTH SOLAPUR, DIST. SOLAPUR-413222, MAHARASHTRA is hereby withdrawn from the end of the academic session next following the date of communication of the said withdrawal order.

Probe

9. Further, if the institution is not satisfied by the order, it may prefer an appeal against the aforesaid order under Section 18 of the NCTE Act, 1993 through 'online mode' available on NCTE's website www.ncte.gov.in within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website.
