4. Recognition is subject to the condition that the affiliating University shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/State Government.
5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of Education to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.



Recognition Order

WHEREAS in terms of Section 13(1) of the NCTE Act, 1993 BHIMRAO RAMRAO AMBEDKAR COLLEGE OF EDUCATION, RUN BY- SHRI RAM SHIKSHA PARISHAD, CHAKKAR ROAD, AMBEDKAR WARD, BETUL, MADHYA PRADESH has submitted an application (Code No.- APW05900/223158 (ADDL)(GIRLS)) to the Western Regional Committee of NCTE, for grant of recognition/permission for conducting B.ED. Course with an additional intake of 100 students on 29-03-2007.

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the SEC teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 13(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to BHIMRAO RAMRAO AMBEDKAR COLLEGE OF EDUCATION, RUN BY- SHRI RAM SHIKSHA PARISHAD, CHAKKAR ROAD, AMBEDKAR WARD, BETUL, MADHYA PRADESH for conducting B.ED. course of SEC of 1 year duration with an additional intake of 100(SEC) under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulation 2007.

4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.

7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.


8. Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.

9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

Order

WHEREAS, recognition was granted to BHIMRAO RAMRAO AMBEDKAR COLLEGE OF EDUCATION, RUN BY - SHRI RAM SHIKSHA PARISHAD, CHAKKAR ROAD, AMBEDKAR WARD, BETUL, MADHYA PRADESH for conducting for B,ED course basic unit vide order No. WRC/5-6/223158/61/2004/8553 dt. 14.12.2004 and additional unit vide order No. WRC/5-6/107th/2008/44928 dated 07.10.2008.

AND WHEREAS, the recognition of B.Ed. course of the institution was withdrawn by WRC in its 115th meeting vide order No.NCTE/WRC//MP/Legal/APW00616/223158/2009/4026-4031 dated 31/03/2009.

AND WHEREAS, the institution preferred an appeal to the Appellate Authority of NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the aforesaid withdrawal order.

AND WHEREAS, the Appellate Authority passed an order No. F.No.89-96/2009/Appeal A-369 dated 18/08/2009. The Council decided "to restore the recognition of the Institution only for the basis unit of 100 students for conducting B.Ed. course as the infrastructure was not sufficient for conducting both basic and additional units."

AND WHEREAS, the recognition was restored vide order No. WRC/5-6/Appeal/APW00616/223158/2010/64034 dated 03/02/2010.

AND WHEREAS, the institution has filed W.P. No. 2468/2010 in the Hon'ble High Court of M.P. Bench at Gwalior. The Hon'ble High Court passed order dated 08/02/2011 that "the matter is remanded back to the respondents to pass a fresh orders after considering the report of the second inspection team and the built up area of the petitioner institution reported by the second inspection team. It is also clarified that the respondents are free to send another inspection team if they are not satisfied with the report of the second inspection team."

AND WHEREAS, the matter was placed in WRC in its 148th meeting and committee decided that Show Cause Notice be issued. Accordingly, show cause notice issued to the institution on 15/06/2011 on the following points:-

- Certified copy of the land documents is required.
- There is no additional built up area for the second unit.
- Land use certificate is required.
- Approved building plan with area earmarked for each course being run in the same premises is required.

AND WHEREAS, the reply dated 19/07/2011 was placed in the 154th WRC meeting and committee decided that comprehensive inspection be caused under clause 8(13) of the NCTE Regulations, 2009 and section 17 of the NCTE Act. Accordingly, inspection of the institution conducted on 26.12.2011.

AND WHEREAS, the VTR was placed in the 160th meeting of WRC held from February 29-March 2, 2012 and it was decided as follows:-

"The case file was seen. In this case the recognition was withdrawn in March 2009. The institution went in appeal before NCTE HQrs. Which quashed the order of WRC partly; hence the institution went in appeal before the Hon'ble High Court of M.P., who quashed the order on the basis of which the institution continued to function.

However, the WRC issued a show cause notice to the institution on 15.6.2011 asking for certified copy of land documents, land use certificate, approved building plan earmarking for each course, and pointed out that additional area was not available. Subsequently, it was decided to cause a comprehensive inspection under Clause 8(13) of NCTE Regulation 2009. The inspection was done on 26.12.2011 and VTR has been received. Perusal of the VTR and viewing of the CD shows a good building with adequate facilities and equipments. Hence VT has strongly recommended the case for restoration.

Hence restoration order be issued."

NOW THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby restores the recognition granted to BHIMRAO RAMRAO AMBEDKAR COLLEGE OF EDUCATION, RUN BY-SHRI RAM SHIKSHA PARISHAD, CHAKKAR ROAD, AMBEDKAR WARD, BETUL, MADHYA PRADESH for conducting B.ED course with an annual intake of 200 seats with the same terms and conditions as mentioned in the recognition order dated 14.12.2004 and 07.10.2008.
