WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 SHRI RAWATPURA SARKAR COLLEGE OF EDUCATION, RUN BY- SHRI LOK KALYAN TRUST, SHRANGARWAR SHRI RAWATPURA SARKAR ASHIRAM, NEAR PWD REAT HOUSE, SATNA ROAD, CHITRAKOAT, DISTT. SATNA, MADHYA PRADESH. has submitted an application (Code No.- APW04720/222249) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting D.ED.(CO-ED.) course with an annual intake of 50 students on 29-12-2006.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to SHRI RAWATPURA SARKAR COLLEGE OF EDUCATION, RUN BY- SHRI LOK KALYAN TRUST, SHRANGARWAR SHRI RAWATPURA SARKAR ASHIRAM, NEAR PWD REAT HOUSE, SATNA ROAD, CHITRAKOAT, DISTT. SATNA, MADHYA PRADESH. for conducting D.ED.(CO-ED.) course of ELE of 2 year duration with an annual intake of 50(ELE) under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulation 2007.
4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
8. Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.
