RECOGNITION ORDER

WHEREAS IN terms of Section 14(1) of the NCTE Act, 1993, BOSTON COLLEGE FOR PROFESSIONAL STUDIES, Plot NUMBER: 1B, 81, 83, 43, 44, 45, 46, STREET NUMBER: PUTALIGHAR, VILLAGE: STROL, POST OFFICE: GPO, MORAR, TEHSIL/TALUKA: MORAR, TOWN/CITY: GWALIOR, DISTRICT: GWALIOR (MP), PIN CODE: 474006 (WRCAPP166) had submitted on 28,10,2009 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the D.El.ED. Course for an annual intake of 50 seats.

- 2. Course of 2 Year with an annual intake of 50 (Fifty) seats from the academic session 2013-2014.
- Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations, 2009.
- 5. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intinate in writing with documentary evidence of its inability to do so.
- The institution shall make admissions only ofter it estains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.
- The institution shall ensure that the recluired number of academic staff for conducting the course is always in position.
- The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
