Refusal Order

(CO-ED) course/additional intake in PG Course of i year(s) duration under Section 15 of the NCTE Act, 1993 to the WRC, NCTE on 1/1/2008.

- AND WHEREAS the inspection of the institution was conducted on 17.07.2009 by a visiting team as per 2. decision of 121st meeting of WRC and NCTE, New Delhi order F.No.89-145/2009/Appeal dtd. 11.06.2009.
- AND WHEREAS in its 122nd/123rd meeting held on July 20-21, 2009 and July 28-29, 2009 respectively 3. the Western Regional Committee after considering the report of the visiting team, perusal of videography as well as other relevant materials furnished by the applicant institution which came to the conclusion that recognition/permission to the said institution be refused for the following reasons.
- Since the recognition for B.Ed. course was refused by the WRC in its 116th meeting, the application 1. for M.Ed. course cannot be considered.
- NOW, THEREFORE grant of recognition/permission to VIPRA ARTS COMMERCE & PHYSICAL 4. EDUCATION, for conducting the M.ED. (CO-ED) course in terms of section 15(3) (b) of the NCTE Act, 1993, is hereby rejected.
- Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for 5. Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
