WITHDRAWAL ORDER

Whereas, recognition was granted to the institution, Rangnath Mama Mogal D.Ed. College, Mugdha apartment, Shethi Compound, Near Gurudwara Road, Pune Road, Dist. – Nashik – 422001, Maharashtra for D.Ed. course with an annual intake of 40 students vide order no. WRC/5-6/18/99/7195-7198 dated 30.12.1999.

And, whereas, the intake was reduced to 30 from the session 2000 – 2001 vide order No. WRC/5-6/2K/9947-53 dated 24.11.2000.

And whereas, the intake was fixed from 30 to 50 vide order No. WRC/5-6/APW03069/112180/85/2006/C-2362-2368 dated 22.08.2006.

And whereas, the institution vide letter dated 10.08.2011 informed that it was suggested in the order dated 22.08.2006 that institution shall shift to its own premises. It has also stated that it sent letter dated 19.08.2010 in this regard. Further, it has been stated in the letter that it informed vide letter dated 02.12.2010 of change of premises to new place w.e.f. 01.01.2011.

And whereas, letter was sent to the institution on 18.10.2011 for applying in the prescribed format with processing fee and other documents.

And whereas, the institution submitted reply dated 12.12.2011, received on 24.12.2011.

And whereas, the application of the institution was processed and deficiencies communicated to the institution vide letter dated 24.01.2012 on the following grounds:

- Total plot area is 335.90 sq. m. and built up area is 214.96 sq. m. which is less than that prescribed in the norms for the course under NCTE Regulations, 2009.
- NOC of country & Town Planning Department from Jt. Director/Deputy, Director/Asstt. Director if land is in urban area; and from Gram Panchayat if land is in rural area, not submitted.
- Notarized copy of change of Land Use Certificate (Diversion order) from Tehsildar/SDO/Collector not submitted.
- Copy of land documents duly certified in original by the Registrar/Sub – Registrar not submitted.
- Search Report from the Advocate in respect of land & building not submitted.
- Certified copy of Khasra, Khatoni B – 1, Demarcation Map and Mutation order from Tehsil office not submitted.
- Building completion certificate be submitted in the enclosed proforma.
- Building Plan from the Municipal Corporation or Gram Panchayat along with copy of the Resolution of Panchayat permission from local authority not submitted. (Gram Panchayat including Sarpanch and Sachiv both if land is in rural area; and from Municipal Corporation if land is in urban area).
- Non – encumbrance certificate issued by Talathi/Tehsildar/SDO not submitted.

- *Undertaking in the prescribed format not submitted.*

And whereas, the institution submitted reply dated **06.02.2012** to allow them time up to **31.03.2012** for submission of documents.

And whereas, the institution now submitted documents vide letter dated **23.02.2012**.

And whereas, the matter was placed before WRC in its **167th meeting** held on **24-26 July, 2012**. The Committee decided that Show Cause Notice be issued on the following points:-

- *The land documents are not submitted.*
- *The area is much less than required.*
- *The institution has shifted to the new premises without waiting for NCTE permission*

And whereas, Show Cause Notice issued to the institution on **17.08.2012**.

And whereas, the institution submitted reply dated **09.11.2012**, received on **15.11.2012**.

And whereas, the matter was placed before the WRC in its **178th meeting** held on **22-24 January, 2013**. The Committee decided that Show Cause Notice be issued to the institution on the following points:

- *Shifting without formal permission;*
- *The society not possessing land in its own name; and*
- *Land being less than required under the Regulations, 2009.*

And whereas, Show Cause Notice issued to the institution on **18/02/2013**.

And whereas, the institution submitted reply dated **15.03.2013**, received on **19.03.2013**.

And whereas, the matter was placed before the WRC in its **183rd meeting** held on **09-10 May, 2013**. The Committee decided that Show Cause Notice be issued to the institution on the following points:


- *This shifting issue came into being because the present premises were not safe for students and also did not meet any of the norms as per NCTE Regulations*

And whereas, Show Cause Notice issued to the institution on **24.06.2013**.

And whereas, the institution submitted reply dated **22.07.2013**, received on **29.07.2013**.

And whereas, the matter was placed before the WRC in its **189th meeting** held on **12-13 August, 2013** and the Committee decided that the Shifting of the said institution be withdrawn for the following reasons :-

- *The institution has not complied with any of the requirements under the NCTE Regulations, 2009, viz. applying formally for permission to shift, depositing the shifting fee, providing information of land required as per the NCTE Regulations, 2009, and all the other requirements. In its letter dated 29.07.2013, the institution has demanded that its change of address be acknowledged. Since the institution has consistently refused to take cognizance of the information sent to it regarding the requirements of the NCTE Regulations, 2009, or shifting, and not complying with any of the provisions.*



Now therefore, in exercise of powers vested under section 17(1) of the NCTE Act, 1993, the recognition of **Rangnath Mama Mogal D.Ed. College, Mugdha apartment, Shethi Compound, Near Gurudwara Road, Pune Road, Dist. – Nashik – 422001, Maharashtra** for M.Ed. course is here by withdrawn from the end of the academic session next following the date of communication of this order.

And now, therefore in exercise of the powers vested in WRC, under section 17 (1) of the recognition of the institution for M.Ed. course is hereby withdrawn from the end of the academic session NCTE Act, 1993, next to date of the withdrawal order.

ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Western Regional Committee grants recognition to **Rangnath Mama Mogal D.Ed. College, Mugdha Apartment, Near Gurudwara, Nasik** for **D.Ed.** course of two year duration from the academic session **2000-2001** with an annual intake of **30** students, subject to fulfilling the following conditions:

1. The institution shall appoint within a period of one year one additional teaching staff possessing the academic qualifications as laid down in the NCTE norms, the salary structure prescribed by the State Government.
2. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
3. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
4. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
5. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
6. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
8. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.

Our Order No.WRC/5-6/18/99/7195-98 dt. 30.12.99 is hereby cancelled

ORDER

In terms of Section 15 (1) of the NCTE Act, 1993 RANGANATH MAMA MOGAL D.ED. COLLEGE, MUGDHA APARTMENT, SHETTY COMPOUND, NEAR GURUDWARA ROAD, NASIK had submitted an application to the Western Regional Committee of NCTE for grant of recognition for revision/refixation in intake from 30 to 50 for D.ED. course of two-year from the academic session 2006-2007.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- (i) The institution has acquired the land for setting up the teacher education institution.
- (ii) The institution has constructed the building for conducting the course on the above mentioned land.

or

- (iii) The institution has made arrangements for conducting the course in rented premises.
- (iv) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. two lakhs.
- (v) The institution has initiated the process for recruitment of Principal/Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition (revision in intake) to RANGANATH MAMA MOGAL D.ED. COLLEGE, MUGDHA APARTMENT, SHETTY COMPOUND, NEAR GURUDWARA ROAD, NASIK from 30 to 50 to D.ED. course of two-year from the academic session 2006-2007.

- (a) The institution shall ensure that it gets duly affiliated for this course to the concerned Board/Directorate and all other formalities required by the Board/Directorate are also completed before the commencement of the course and admission of the students to the course and a report to this effect should be sent to the Committee.
- (b) That the institution will ensure that 06 (one Principal and 05 lecturers) faculty members are in position for an intake of 50 students or less before commencement of the course and a report to this effect duly verified by the Director of the concerned SCERT shall be sent to the Committee within one month of commencement of the course. For intake of students in excess of the prescribed unit, the number of full time teachers shall be increased proportionately.
- (c) The institution shall within one month of the receipt of recognition create an endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- (d) The institution shall shift to its own premises within three years from the date of recognition (In case the course is started in rented premises).
- (e) The institution shall comply with the various other norms and standards as prescribed in the NCTE Regulations.

4. Recognition is subject to the condition that the Board/Directorate shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/State Government.
 5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of Education to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
