**ORDER**

Whereas the applicant institution SHAYOG SEVA BHAVI SANSTHA, VISHNUPURI, NANDED 431606 MAHARASHTRA (code – 123043) had applied for grant of recognition of additional unit/course of B.Ed. U/s 15 of the NCTE Act, 1993 to Western Regional Committee, NCTE, Bhopal.

And whereas WRC in its 69<sup>th</sup> meeting held on February 23, 2005, considered the case carefully and noted that the applicant institution is already conducting B.Ed. course (Code No.123043) recognised by NCTE.

And as per the provision stated hereunder of NCTE (amendment) regulation dated 21.08.2003, the Western Regional Committee found your proposal incompetent for further processing and issued show-cause notice dated 11.03.2005 U/s 15(3)(b) of NCTE Act 1993 to your institution, thereby giving an opportunity to the applicant institution to make written representation, if any.

(i) “No institution shall be permitted to apply for enhancement of its intake over and above the basic unit as indicated in the Appendices 3 to 14 of these regulations and for starting a new course or training in teacher education under sub-section (1) of Section 15 of NCTE Act, 1993 unless

- (a) it has been granted permanent recognition and has continuously run teacher training programme or course for a period of three years; and
- (b) it has accredited itself with the National Assessment and Accreditation Council (NAAC) with a grade of B+ on a nine point scale developed by NAAC.

And whereas the applicant institution had submitted their reply/representation to the above stated show-cause notice vide their letter dated 28.03.2005. The said representation of the institution as well as the materials submitted with it were duly considered by Western Regional Committee in its 76<sup>th</sup> meeting held on August 6-8, 2005. and it came to the conclusion that the recognition to the said institution be refused for the applicant institution had failed to make up the above stated provision of regulation.

Now, therefore, it is hereby issued that the recognition to conduct additional unit/course of B.Ed. is refused to the institution. Also ordered that a copy of the order be published in the official gazette.


