Order

WHEREAS, the applicant institution viz Govt. Basic Training College for Men, Dabka, Dist. Baroda had applied for recognition under Section 14 of the NCTE Act, 1993 for PTC course.

A visit of the applicant institution was carried out on 22.07.98 by a visiting team constituted by the Regional Committee.

AND WHEREAS the Regional Committee, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had opined that the applicant institution does not fulfil the requirements and issued a notice on 24.08.98 to the applicant institution under proviso to Section 14 (3) (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

AND WHEREAS the applicant institution was directed on April 19, 2000 to submit compliance of the deficiencies communicated vide above mention letter. The institution provided copy of the letter submitted earlier. The visiting team report and the said representation of the institution as well as other documents and materials submitted were duly considered by the Regional Committee on June 8-9, 2000 which came to the conclusion that recognition to the said institution be refused for the following reasons:

1. Building is not usable as it is very old and dilapidated building. The state PWD has declared building not suitable for use.
2. Furniture in poor condition and not maintained properly.
3. Library and laboratories are not functional.
4. The entire staff is not qualified as prescribed by NCTE norms.
