## ORDER

The 7 (seven) institutions mentioned in para 3 below submitted applications to the Western Regional Committee of National Council for Teacher Education for grant of recognition to B.Ed. in terms of Section 14(1) and 15(1) of NCTE Act, 1993, among others.

2. The WRC at its extended 87<sup>th</sup> meeting held on August 30-31, 2006 at NCTE, WRC, Bhopal considered applications of the institutions included in the Agenda for the meeting and after careful examination of relevant documents, Visiting Team Reports, Video Recording etc. found the institutions mentioned in para 3 below fit for grant of conditional recognition of the courses and intake mentioned against their names. Thereafter, the institutions submitted compliance reports removing deficiencies mentioned therein.

3. Now, therefore, in exercise of powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to these institutions w.e.f. the session 2006-2007 for the course and intake mentioned against their names and addresses shown as under.

4. The institutions shall ensure the fulfillment of the following :-

- The institutions shall maintain the teaching staff strength of 1+7 for the proposed B.Ed. course.
- The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.
- The institutions shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institutions shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.
- That the Reserve fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the managements / institutions.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc.

- (g) The institutions shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- (h) The institutions shall regularly update their website.
- (i) The institutions intending to run the teachers training programme approved above in a rented premises are required to submit report in compliance of the requirement of NCTE Regulations on the subject.

5. If any of the institutions contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act 1993. The NCTE Hqrs. May also cause inspections under Section 13 of NCTE Act, 1993.

WHEREAS, Recognition/Permission was granted to the institute RAIBA MAHILA P.T.C. COLLEGE, Plot no.-905, ASHRAM CHARRASTA, RANASAN, PO. PUNDHARA, TA. VIJAPUR, DIST - MEHSANA, GUJARAT - 382880, under section 14 of NCTE Act, 1993 for conducting P.T.C. (Girls) course with an intake of 50 from the academic session 2007-2008 vide order No. WRC/5-6/103<sup>rd</sup>/2008/34503-34509 dated 13.05.2008.

AND WHEREAS, in compliance of High Course order VT be constituted to the institution for ATD course (APW08281/324173/324037)

AND WHEREAS, The inspection was conducted on 10.07.2011.

AND WHEREAS, VT report of ATD course was considered in this meeting of the same institution by the WRC in its 153<sup>rd</sup> meeting of WRC as per committee decision Show Cause Notice be issued on the following grounds:-

1. Inadequate land and dilapidated building for B.Ed. and P.T.C. course.

AND WHEREAS, Show Cause Notice issued to the institution on 06.01.2012, institution replies on 07.02.2012.

AND WHEREAS, the matter was considered in 161<sup>st</sup> meeting of WRC, Committee decided VT be constituted.

AND WHEREAS, The inspection was conducted on 18-19 May, 2012.

AND WHEREAS, VT report was considered by the WRC in its 166<sup>th</sup> meeting of WRC as per committee decision Show Cause Notice be issued on the following grounds:-

1. The Smt. Panchsheel Education Trust is running two colleges RAIBA MAHILA P.T.C. COLLEGE (Code - 322429) and SMT. PATEL MANJULABEN VITTHALBHAI COLLEGE OF EDUCATION (code - 323256) from the same building.
2. The multipurpose hall in both is the same and it is smaller than the required specification.
3. The science and psychology labs. are not adequately equipped as required looking to the number of students.

AND WHEREAS, Show Cause Notice issued to the institution on 16.08.2012, Institution has not submitted reply.

AND WHEREAS, the matter was considered in 178<sup>th</sup> meeting of WRC, Committee decided to withdraw recognition for conducting P.T.C. (Girls) course.

Now, therefore, in terms of Section 17(1) of the NCTE Act, 1993 the recognition of RAIBA MAHILA P.T.C. COLLEGE, Plot no.-905, ASHRAM CHARRASTA, RANASAN, PO. PUNDHARA, TA. VIJPUR, DIST - MEHSANA, GUJARAT - 382880, for the P.T.C. (Girls) course is hereby withdrawn from the end of the academic session next following the date of this withdrawal order.

Affiliating Body/ State Govt. are advises not to admit/ allot any student in P.T.C. (Girls) in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.

Further, if the institution is not satisfied by the order, they can prefer an online appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1- Bahadur Shah Zafar Marg, Near RTO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
