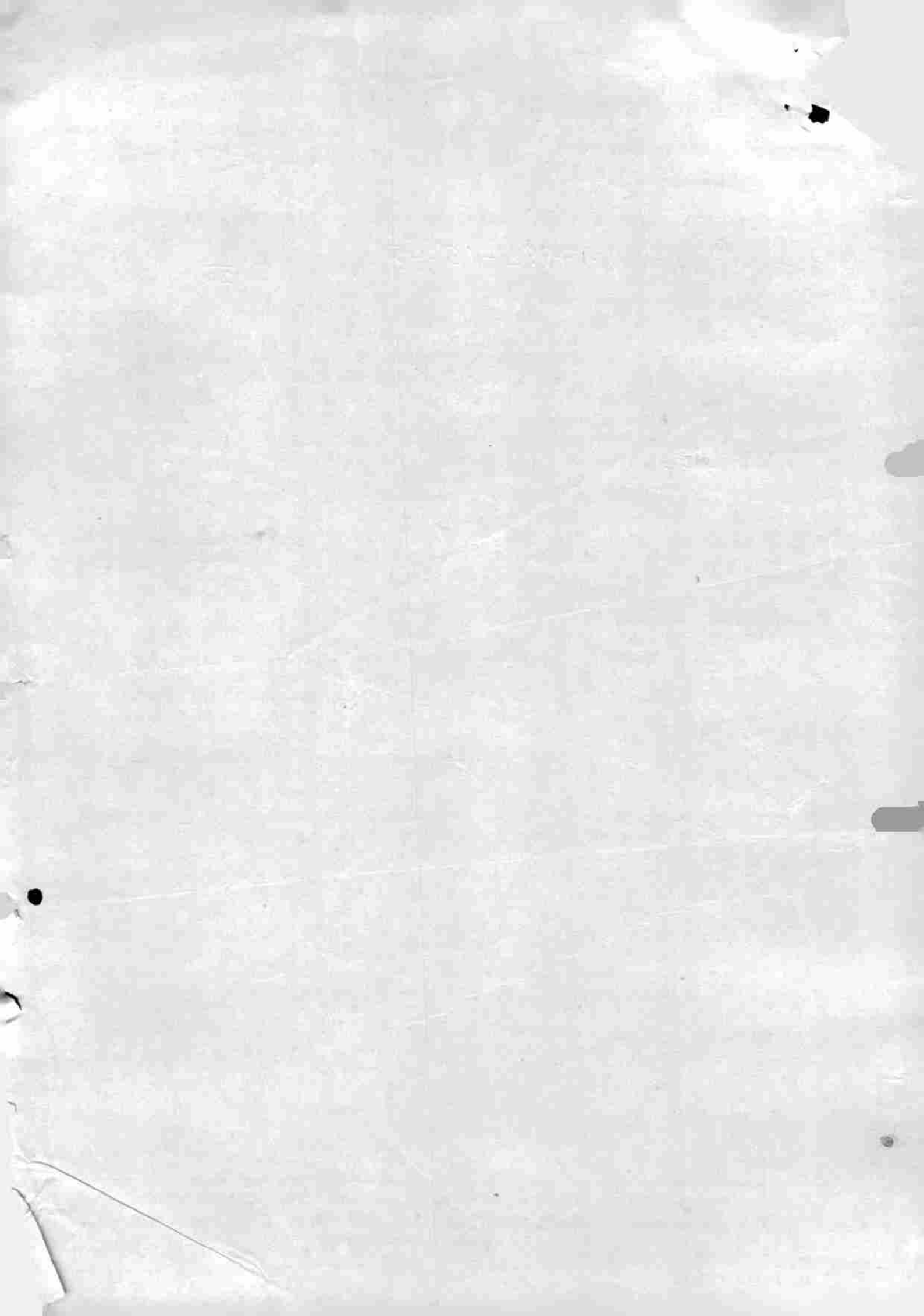
3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to SHRI A.C. SHUKLA POST GRADUATION COLLEGE OF EDUCATION, 402, BALESHWAR AVENUE, 4TH FLOOR, OPP. RAJNATH CLUB, S.G. HIGHWAY, AHMEDABAD-387130, GUJARAT. for conducting M.ED. course of One year duration with an annual intake of 25 (PG) students under clause 7(10) of Regulation dated 13-1-2005 (if applicable) subject to fulfillment of the following:

I. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Western Regional Committee.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

III. That the institution shall obtain an unconditional letter of recognition in terms of 7(12) of NCTE Regulation 13-1-2005 (if the recognition is being granted under 7(11)). Further the institution shall make admission only after it obtain unconditional letter of Recognition from the Western Regional Committee and affiliation from the examining body in terms of clause 8(10) of the NCTE Regulation, 13-1-2005.

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the **Shri A. C. Shukla Post Graduate College of Education, Mahudha Road, Mehemadabad, Kheda, Gujarat** by affidavit dt.23.01.2015 has consented to come under new Regulations and sought for one basic unit in **M.Ed.** of two year duration which require additional facilities

3. And whereas, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely,

- i. The institution shall identify/select the full component of the faculty/staff, as per NCTE Regulations, 2014, and approval of the affiliating body be obtained and the same may be conveyed to the Western Regional Committee in the prescribed manner and in the prescribed proforma, giving details of qualification and experience of the Faculty/Staff selected alongwith the letter of approval of the affiliating body by that date.
- ii. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, as per Regulations, 2014 and inform the Regional Committee with required documents such as certified
- iii. copy of registered land documents, Certificate for Land Use (CLU), copy of approved Building Plan (BP) and Encumbrance Certificate (EC) in proof of having the additional facilities, before May 30, 2016. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting team at the time of inspection.
- iv. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the **NCTE Regulations, 2014** the **Western Regional Committee (NCTE) hereby issues the revised recognition order to Shri A. C. Shukla Post Graduate College of Education, Mahudha Road, Mehemadabad, Kheda, Gujarat for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2016-17 subject to fulfillment of the conditions mentioned above.**

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/5-6/98th/2007/C-17998-18005 dt. 21.06.2007 and WRC/5-6/98/2007/C-19470-19476 dt. 13.07.2007 be treated as cancelled from the date of issue of this revised order.
