Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- And whereas, the H.M. Patel Institute of English Training And Research, Vallabh Vidyanagar, District Anand, Gujarat - 388120 by affidavit dt.07.01.2015 has consented to come under new Regulations and sought for two basic unit in B.Ed. which require additional facilities
- 3. And whereas, it has been decided to permit the institution to have two basic unit of 50 students each subject to the institution fulfilling following conditions namely,
- i. The institution shall identify/select the full component of the faculty/staff, as per NCTE Regulations, 2014, and approval of the affiliating body be <u>obtained latest by 29.02.2016</u> and the same may be conveyed to the Western Regional Committee in the prescribed manner and in the prescribed proforma, giving details of qualification and experience of the Faculty/Staff selected alongwith the letter of approval of the affiliating body by that date.
- ii. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, as per Regulations, 2014 and inform the Regional Committee with required documents such as certified copy of registered land documents, Certificate for Land Use (CLU), copy of approved Building Plan (BP) and Encumbrance Certificate (EC) in proof of having the additional facilities, before May 30, 2016. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting team at the time of inspection.
- iii. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to H.M. Patel Institute of English Training And Research, Vallabh Vidyanagar, District Anand, Gujarat 388120 for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic unit of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned above.
- Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

- The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. if it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Recognition order no. WRC/5-6/2K/145 dt. 10.01.2001 be treated as cancelled from the date of issue of this
revised order.

ORDER

Intexercise of the powers vested under section 14(3) (a) of the National Council for Teacher FAucation(NCTE) Act, 1993, the Western Regional Committee grants recognition to II.M. Patel restitute of English Training and Research, Vallabh Vidyanagar, Dist. Anand for B.Ed. (Elish) and M.Ed. (English) courses from the academic session 2000-2001 with an annual intakes of 90 for B.Ed. (English) and 10 for M.Ed. (English) students, subject to fulfilling the Inflowing conditions:

1. The institution shall appoint within a period of one year two additional teaching staff prossessing the academic qualifications as laid down in the NCTE norms, the salary structure prescribed by the State Government as the case may be.

2. All such teachers already appointed who do not fulfil the NGTE norms shall acquire the

qualifications as per the norms within a period of two years of this order.

The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.

The admission to the approved course shall be given only to those candidates who are eligible Sas per the regulations governing the course and in the manner laid down by the affiliating university/State Government.

Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come

into force.

- 6. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
- 7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.

8. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.

9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.
