SHOW CAUSE NOTICE

Whereas recognition was granted to **GRAM NIRMAN KELVANI MANDAL, AT AND POST THAVA, BHARUCH-393130, GUJARAT** (Code No. APW00208/323107) under section 14 of NCTE Act, 1993 for conducting PTC course vide order No.WRC/2-32/63/2004/5290 dtd. 24.08.2004 with an annual intake of 50 students.

And whereas, the matter was considered by WRC in its 147th meeting. Committee decided that VT to be constituted under section 17 on the basis of complaint made by Government of Gujarat against the institution.

And whereas, the inspection of the institution was conducted on **14.07.2011**. The visiting team report was placed in 153rd meeting of WRC and the Committee decided to issue show cause notice under section-17 (1) of the NCTE Act, 1993 on the following points:-

1. Psychology lab is located in a dilapidated building.
2. Infrastructure not sufficient for 200 students in P.T.C. course.

Now therefore, in exercise the powers vested in the Western Regional Committee under section 17(1) of the NCTE, Act, 1993 an opportunity is hereby given to the said institution under provision of 17(1) of the NCTE Act, 1993 for making a written representation within 30 days of the issue of this notice before withdrawal of recognition order on the grounds mentioned above. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Western Regional Committee shall take the decision under Section 17 (1) of NCTE Act, 1993, as it deems fit and proper.
