In terms of Section 14 (1) of the NCTE Act, 1993 College of Education, At & PO. Vadasma, Dist. Mehsana had submitted an application to the Western Regional Committee of NCTE for grant of recognition for starting B.Ed. of one year duration from the academic session 2002-2003 with an annual intake of 100 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- (i) The institution has acquired the land for setting up the teacher education institution.
- (ii) The institution has constructed the building for conducting the course on the above mentioned land.

or

- (iii) The institution has made arrangements for conducting the course in rented premises. The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. three lakhs.
- (iv) The institution has initiated the process for recruitment of Principal/Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to College of Education, At & PO. Vadasma, Dist. Mehsana for B.Ed. of one year duration from the academic session 2002-2003 with an annual intake of 100 students subjects to fulfillment of the following.

- (a) That the institution will ensure that 08 (one Principal and 07 lecturers) faculty members are in position for an intake of 100 students before commencement of the course and a report to this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
