WITHDRAWAL ORDER

Whereas, recognition / permission was granted to SEWAK SHRI RAM COLLEGE OF EDUCATION, RUN BY NIRMAL SEWA ASHRAM, PLOT NO. -78, KHASRA NO. 210, AHOOKHANA GOVIND POUR GHAS MANDI, GWALIOR, M.P. under section 14 (3)(a) of the National Council for Teacher Education Act 1993 for conducting D.ED. Course with an annual intake of 50 Seats vide order number WRC/5-6/106/2008/40493 dated 29.8.2008.

And whereas, the inspection of the institution was conducted on 26.5.2010, consideration of the original file of the institution, VTR. video graph and other relevant documents, in its 136<sup>th</sup> meeting held on 5<sup>th</sup> & 7<sup>th</sup> June 2010, the Western Regional Committee of National Council for Teacher Education (Here-in-after called "WRC") was satisfied that the institution had contravened the following provisions of the NCTE Act, Rules and Regulations, order framed there under;

- (i) The institution does not exist at the address mentioned in the application. The institution contravened the 8(7) of Regulations 2007.

And whereas, the WRC directed that an opportunity be given to the institution to make the written representation as to the aforesaid contraventions within a period of 30 days from the date of issue of the show cause notice before withdrawal of recognition / permission and issued the show cause notice dated 05.07.2010.

And whereas, the institution submitted the written representation dated 1.8.2010 which was considered by WRC in its 140<sup>th</sup> meeting held on 14<sup>th</sup> -15<sup>th</sup> September 2010.

And whereas, the WRC considered the written representation of the institution in the light of VT report, video graph and other relevant documents on record. As regards contravention number (1), the institution stated that the institution exist at the address mentioned in the application which was not acceptable to WRC because the institution does not exist at the address mentioned in the application.

Now therefore, the WRC, in exercise of its powers under section 17(1) of the NCTE Act, decided to withdraw the recognition / permission to the institution to conduct the D.Ed. course from the end of the academic session next following the date of communication of this order on account of following contraventions of the provisions of the NCTE Act, Rules and Regulations framed there under;

- (i) The institution does not exist at the address mentioned in the application. The institution contravened the 8(7) of Regulations 2007.

Affiliating body and the State Government are advised to cancel the affiliation of the institution under the provisions of section 17(3) of the NCTE Act and not to admit / allot students in the institution after the end of the academic session next following the date of this withdrawal order. In accordance with section 17(4) of the NCTE Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking the course or training in such institution, shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or any school, college or other educational body owned or aided by the Central Government or any State Government.

Further, if the institution is not satisfied by this withdrawal order, it can prefer an appeal under section 18 of the NCTE Act to National Council for Teacher Education, Hans Bhawan, Wing II, 1 Bahadur Shah Zafar Marg, New Delhi 110 002, within 60 days from the date of this withdrawal order.
