9 The institution shall ensure that the required number of academic staff for conducting the course is always in position

10 Further, subject to the provision of NCTE Act 1993, The institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC , affiliating University/Body , the State Government etc, applicable.

11. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.


12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information for having fulfilled the norms & standard and other required conditions.

13 If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

14. Further, if the institution is not satisfied by the order , they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.



**Recognition Order**

WHEREAS in terms of Section 14(1)/Section of the NCTE Act, 1993 **REWANCHAL EDUCATION COLLEGE,(RUN BY AMBIKESH CHILDREN EDUCATIONAL & CULTURAL WELFARE SOCIETY) NEAR REWANCHAL PUBLIC SCHOOL,TILAK NAGAR, REWA-486001,MADHYA PRADESH** has submitted an application (Code No.- APW05820/222297 (CO.ED)) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting **D.ED.(CO-ED)** course with an annual intake of **50** students on **29-03-2007** .

2. AND WHEREAS in its **114<sup>th</sup>** meeting held on **Feb.4-5,2009** the Western Regional Committee after considering the report of the visiting team as well as other relevant material furnished by the applicant institution decided to refuse recognition on the institution for **D.ED** course and accordingly the Refusal order no. **WRC/ APW05820/222297 /114<sup>th</sup> /2008/51141-51146 dt.19.02.2009** was issued to the institution

5. AND WAHEREAS the correspondent, **REWANCHAL EDUCATION COLLEGE,(RUN BY AMBIKESH CHILDREN EDUCATIONAL & CULTURAL WELFARE SOCIETY) NEAR REWANCHAL PUBLIC SCHOOL,TILAK NAGAR, REWA-486001,MADHYA PRADESH** has preferred an appeal to NCTE New Delhi against the decision of WRC refusing recognition under section 18 of the NCTE Act, 1993 against the said Order.

6. AND WHEREAS having considered the oral submission by the representative of the institution, the written representation, the record of the case and V.T. Report, the Appellate Authority decided to reverse the order of NCTE, WRC. Accordingly, the appeal was accepted with direction to WRC to grant recognition to the institution immediately.

5. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, , and as per the NCTE, New Delhi Order No.**F.No. 89-214/2009/Appeal. Dated : 13.07.2009** the Western Regional Committee hereby grants recognition / permission to **REWANCHAL EDUCATION COLLEGE,(RUN BY AMBIKESH CHILDREN EDUCATIONAL & CULTURAL WELFARE SOCIETY) NEAR REWANCHAL PUBLIC SCHOOL,TILAK NAGAR, REWA-486001,MADHYA PRADESH** for conducting **D.ED.** course **from academic session 2009-2010** of **ELE** of 2 year duration with an annual intake of **50 seats** under clause 7(11) of NCTE( Recognition Norms & Procedure ) Regulation 2007.

6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.

7. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

8 The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
