**ORDER FOR CHANGE OF NAME OF INSTITUTION AND  
AFFILIATING/ EXAMINING BODY**

WHEREAS, the recognition was granted to Maharashtra Academy of Engineering and Educational Research, MIT B.Ed. College, Kothrud, Pune, Maharashtra by Western Regional Committee (WRC) for B.Ed. Course of one year duration with an annual intake of 100 seats vide order No.WRC/5-6/92/2006 dated 23.01.2007.

2. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution viz.MAEER's MIT School of Education & Research, Dist. Pune, Maharashtra vide order No.WRC/APW03795/123452/2015/149749-9756 dated 03.08.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.

3. **AND WHEREAS**, the institution has submitted a request for change the name of the institution MAEER's MIT School of Education and Research, Pune, Maharashtra to Dr. Vishwanath Karad MIT World Peace University, School of Education, Pune, Maharashtra and also to change the name of affiliating body from "Savitribai Phule University, Pune, Maharashtra to Dr. Vishwanath Karad MIT World Peace University, School of Education, Pune, Maharashtra, the same was considered by WRC in its 313<sup>th</sup> meeting and subsequently in 314<sup>th</sup> Meeting and it was decided that:-

"...The Committee considered the matter and observed as under:-

- The institution submitted an application for change of affiliating university as well as change of name of the institution vide application dated 15/11/2019.
- The proposed university has been gazette notified in the State of Maharashtra.
- The existing institution MAEER's MIT School of Education and Research, Pune Maharashtra for B.Ed. programme with an annual intake of 100 students vide Revised Recognition Order No. WRC/APW03795/123452/2015/149756 dated 03/08/2015.
- The institution has submitted NOC from the previous and proposed university.
- The land documents and sponsoring Trust/Society of the previous institution and proposed university are same.

In view of the above the Committee decided to allow the change of name of the institution as well as affiliating body as under:-

- The name of the existing institution is allowed to be changed from MAEER's MIT School of Education and Research, Pune, Maharashtra to Dr. Vishwanath Karad MIT World Peace University, School of Education, Pune, Maharashtra from the date of issue of Gazette Notification by Govt of Maharashtra notifying the University.


