## ORDER

Whereas, the institution namely Institute Of Advanced Studies In Education, Gandhi Vidya Mandir, Sardarshahar, Dist.- Churu, Rajasthan was granted recognition by NRC NCTE for M.ED Course with an annual intake of 30 students vide order no. F.NRC/F-3/RJ-5/2000/4502 dt 25.07.2000.

And whereas, Revised order issued to the institution vide order no. NRC/NCTE/RJ-COMMON ORDERS/2015/110080, dt: 31.05.2015 with an annual intake of 50 and on the name of Institute Of Advanced Studies In Education, Gandhi Vidya Mandir, Sardarshahar, Dist. - Churu, Rajasthan.

And whereas, Corrigendum was issued to the institution vide order no. NRC/NCTE/RJ-05/2015/117270-274 dt: 18.06.2015 with an annual intake of 50 and on the name of Buniyadi Shikshak Prashikshan Mahavidyalaya, Gandhi Vidya Mandir, Sardar Shahar-331401, Rajasthan.

And whereas, the matter was placed in 281st. Meeting of NRC held on February 20-21, 2018 and the Committee decided that "The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order."

Accordingly, a Show cause notice was issued to the institution on 28.03.2018 and its reply received on 09.11.2020.

And whereas, the Institution vide letter dt. 24.08.2022 and e-mail dt. 02.09.2022 made a request for merging seats of M.Ed allotted to IASE Deemed to be University and Buniyadi Shikshak Prashiksan Mahavidyalaya in the name of IASE deemed to be University, Sardarshahar, Rajasthan.

And whereas, the matter was placed in the 370th meeting of WRC held on 10th and 12th September, 2022, and the committee has decided the following:

"...The original file of the Institution along-with other related documents, were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

 Initially, recognition order dated 25.07.2000 for M.Ed. course of one year duration with intake of 30 was issued in the name of Institute of Advanced Studies in Education, Gandhi Vidya Mandir, Shardar Shahar-331401, Churu, Rajasthan.

 Revised order dated 31.05.2015 for M.Ed course of two years duration with intake of 50 was issued in the name of Institute of Advanced Studies in Education, Gandhi Vidya Mandir, Shardar Shahar-331401, Churu, Rajasthan.

 Corrigendum dated 18.06.2015 issued for M.Ed. course with intake of 50 in the name of Buniyadi Shikshak Prashikshan Mahavidyalaya, Gandhi Vidya Mandir, Sardar Shahar-331401, Rajasthan.

Now, the institution has submitted representation dated 24.08.2022, wherein requested that due to merger of institution and its academic programmes with the IASE (Deemed to be University), Sardarshahr, the institution's M.Ed. programme needs to be transferred to the IASE (Deemed to be University), Sardarshahr, Rajasthan.

The Committee observed that on previous occasion, B.Ed. course of the institution has been permitted in the name of IASE (Deemed to be University), Sardarshahr, Rajasthan.

In view of the above, the Committee decided that the institution be allowed to run the M.Ed. programme with intake of 50 in the name of IASE (Deemed to be University), Sardarshahr, Rajasthan. Accordingly, permission order be issued to the institution, Affiliating Body/State Government and all others concerned."

Now therefore, the institution is hereby granted for change of BUNIYADI SHIKSHAK PRASHIKSAN MAHAVIYDLAYA to Institute Of Advanced Studies In Education (Deemed to be university) with a permission to run the M.Ed course with total intake 50 (One unit).
