ORDER

Whereas, recognition was granted to the institution, **Shri Govind Shikshak Prashikshan Mahavidyalaya, Churu Road, Near Police Station, Bissau, district-Jhunjhunu, State-Rajasthan, Pin code-331030** for **D.El.Ed** course with an annual intake of course 50 students vide order no. **NRC/NCTE/F-7/RJ-955/2007/28706-12** dt. 24.09.2007.

And whereas the institution vide letter dt. 20.04.2019 & 11.10.2019 submitted an application for the change of D.El.Ed course from **co-ed to Girls**.

NOW THEREFORE, the institution is hereby permitted to change of category from **co-ed to Girls** with immediate effect for conducting D.El.Ed course of two years.
