## WITHDRAWAL ORDER 220447

WHEREAS, recognition was granted to the institution namely **MAULANA AZAD SHIKSHA MAHAVIDYALAYA, SUBHASH NAGAR,GONDPARA, BILASPUR, CHHATISGARH** Vide Order No. WRC/2-32/74/2004/8362 dt. 28.10.2005 for **B.Ed.** course of 1 year duration with an annual intake of 100 students.

AND WHEREAS, the revised recognition order was issued to the institution MAHAVIDYALAYA, SUBHASH SHIKSHA namely MAULANA AZAD no. F.No. CHHATISGARH vide order BILASPUR, NAGAR, GONDPARA, 27.05.2015 for B.Ed. WRC/APW00266/723003/2015/137586-137593 dt. Programme of two years duration with an annual intake of 100 students from the academic session 2015-16.

**AND WHEREAS**, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

**AND WHEREAS**, a Show Cause notice was issued to the institution on 08.08.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.

**AND WHEREAS**, the reply of show cause notice was submitted by the institution ON 23.08.2016 AND 24.10.2016.

**AND WHEREAS**, the matter was placed in 290<sup>th</sup> Meeting held on March 21 to 23, 2018 of WRC and the Committee decided that:-

"...The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice was issued on 08.08.2016, the institution replied on 23.08.2016.

The institution had requested vide letter dated 23.08.2016 for reduction of unit to one. However, the institution has not submitted the latest staff profile approved by the Registrar.

The additional FDR for Rs.4.00 lakhs not submitted (in joint name) in original.

# Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

Accordingly, a letter was issued to the institution on 27.03.2018 and its reply received in WRC on 24.04.2018.

**AND WHEREAS,** the matter was placed in 322th Meeting held on March 23 to 24, 2020 of WRC and the Committee decided as under:-

"... The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

This is a RPRO case. As per the decision of WRC in 290th meeting, SCN was issued to the institution vide dated 27th March 2018. The reply to SCN submitted by the institution vide dated 20th April 2018 was considered by WRC and following deficiencies were noticed by WRC:-

- The institution photocopy of staff profile (1+9) which is not approved by the affiliating body.
- The principal is not having the required 8 years teaching experience in Secondary Teacher Education Institution. The Principal also does not have Ph.D degree.
- The institution has not appointed faculty for Health & Physical education, Fine Arts and Performing Arts.
- The percentage of marks of the qualification have not been mentioned therefore, the eligibility of the teaching staff as per NCTE norms cannot be ascertained.

### In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act."

**Accordingly,** Final Show Cause Notice was issued to the institution on 11.12.2020 and its reply received on 09.01.2021.

**AND WHEREAS**, the matter was placed in 366<sup>th</sup> Meeting held on July 12<sup>th</sup> and 14, 2022 of WRC and the Committee decided that:-

"...The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

First Show Cause Notice was issued on 08.08.2016 and the final SHOW CAUSE NOTICE was issued on 11.12.2020. Reply of Final Show Cause was not received within stipulated time.

- The institution has not submitted the original staff list approved by the affiliating
- The institution has not uploaded the necessary information on its official website.
- The institution has also not submitted the filled copy of the Performance Appraisal
- Report

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act 1993, with effect from the end of the academic session next following the date of communication of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby Withdraws recognition of MAULANA AZAD SHIKSHA MAHAVIDYALAYA, SUBHASH NAGAR, GONDPARA, BILASPUR, CHHATISGARH granted for B.Ed. course on the grounds mentioned above from the end of the academic session 2023-2024 following the date of communication of the said order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s mode" "online through 1993 NCTE's website www.ncte.gov.in within 60 days from the date of issue of this Order. The Act, guidelines for filing appeal may be seen on NCTE's website.
