WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely SPECTRUM COLLEGE OF EDUCATION, KHASRA NO.1234, VILL/POST-NARDAHA, TEH-Order RAIPUR, CHHATTISGARH-493111 Vide AARANG, 27.08.2012 No. WRC/APP1552/169/B.ED./2012/94430, 32,515-520 dt. for **B.Ed.** course of 1 year duration with an annual intake of 100 students.

AND WHEREAS, the revised recognition order was issued to the institution namely SPECTRUM COLLEGE OF EDUCATION, KHASRA NO.1234, VILL/POST-RAIPUR, CHHATTISGARH-493111 vide order NARDAHA, TEH-AARANG, 31.05.2015 for B.Ed. WRC/APP1552/2015/141645-141651 dt. no. F.No. Programme of two years duration with an annual intake of 100 students from the academic session 2015-16.

AND WHEREAS, the matter was placed in 286th Meeting held on January 16-17. 2018 of WRC and the Committee decided that:-

"...The case file was seen. As per Revised Recognition order dated 31.05.2015, the institution was directed to submit duly approved list of faculty, maintenance of FDRs as per NCTE Regulations, 2014 and Building Completion Certificate issued by a Government Engineer.

The institution has not submitted staff profile (1+15) approved by the Registrar, and Building Completion Certificate is not signed by a Govt. Engineer.

It needs to submit additional FDR for Rs.4.00 lakhs (in joint name) in original (Total requirement is 12.00 lakhs).

Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month."

Accordingly, a Show Cause Notice was issued to the institution on 22.01.2018 and its reply received in WRC on 02.02.2018 and 26.02.2018.

AND WHEREAS, the matter was placed in 314th Meeting held on 13th to 15th and 22nd July 2020 of WRC and the Committee decided as under:-

"... This is a RPRO case. RPRO issued on 31.05.2015 for two units of B.Ed programme. SCN issued on 22.01.2018 and reply received on 02.02.2018 and 19.02.2018.

After examination of the documents, the following is observed :-

- Except the staff at Sr. No. 1,2,3,4, all staff members are not eligible and qualified as per NCTE Regulations 2014, as amended vide notification dated 09th June 2017.
- As per building completion certificate, the total built area is 21065 sq. ft as against requirement of 2000 sqm.

In view of the above, the Committee decided that last opportunity be given to the institution to submit compliance to the Show Cause Notice by the institution within 30 days u/s 17 of the NCTE Act."

Accordingly, Final Show Cause Notice was issued to the institution on 06.08.2020 and its reply received on 17.08.2020.

AND WHEREAS, the matter was placed in 366th Meeting held on July 12th and 14, 2022 of WRC and the Committee decided that:-

"...The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

SHOW CAUSE NOTICE as issued 22.01.2018 and 06.08.2020

- The institution has not submitted the approval qualified staff as per the NCTE norms
- There are three photocopies of the BCC found in the file. All are having different built up area. There should be only one in consonance with the building plan.
- Necessary information has not been uploaded on its website.
- As per building completion certificate, total built up area is less than 2000 sgm. which is less.
- The institution has also not submitted the filled copy of the Performance Appraisal Report.

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act, 1993, with effect from the end of the academic session next following the date of communicating of the said order."

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Western Regional Committee now hereby **Withdraws** recognition of **SPECTRUM COLLEGE OF EDUCATION, KHASRA NO.1234, VILL/POST-NARDAHA,TEH-AARANG, RAIPUR, CHHATTISGARH-493111** granted for **B.Ed.** course on the grounds mentioned above from the end of the academic session **2023-2024** following the date of communication of the said order.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
