**Refusal Order**

Whereas, Tiger Welfare Association, Jayhind Saw Mill, Subhash Road, Beed, -431132, Maharashtra had submitted the application on 29.04.2018 to the Western Regional Committee of the NCTE for grant of recognition to Iqra Urdu D.Ed.College, Plot No. 3385, Survey No. 45, Opp. Market Committee, Bahirwadi, Beed-224738, Maharashtra for starting the D.Ed. (Urdu) course.

And Whereas, the matter was placed before WRC in its 120<sup>th</sup> meeting held on 23-24 June, 2009 and the committee decided that in the light of letter No. TCM 2007/(CR.2/07)/Sc-4 dated 30/08/2007 received from the State Govt. of Maharashtra letter F.No. 46-3/2008NCTE(N&S) dated 1 October, 2008 and F.No.49-27/2007/NCTE(N&S) dated 31 October, 2008 from the Member Secretary, NCTE New Delh, the case will not be processed further, hence file be closed. Accordingly order was issued to the institution on 03/07/2009.

And whereas, the institution preferred appeal at NCTE Hqrs under Section 18 of NCTE Act, 1993. The Appellate Authority vide order F.No.89. 735/2009-Appeal A 735/2009-Appeal A 3785 dated 08.10.2009 accepted the appeal. Set aside WRC order dated 03.07.2009 and remanded back the case to WRC for processing the case further for causing inspection of the institution to ascertain the availability of adequate infrastructure and other facilities as per NCTE norms and thereafter passing appropriate order

And whereas, Deficiency letter was issued to the institution on 20.02.2010.

And whereas, the institution submitted reply dated 16.04.2010 which was placed before WRC in its 147<sup>th</sup> meeting and the committee decided that show cause notice be issued to the institution on the following points:-

- Certified copy of the land documents not submitted.
- Land Use Certificate not submitted.

And whereas, show cause notice was issued to the institution on 07.04.2011. The institution submitted reply dated 20.04.2011.

And whereas, the matter was placed before WRC in its 149<sup>th</sup> meeting and the committee decided that VT be constituted.

And whereas, the inspection of the institution was conducted on 31.07.2011.

And whereas, the matter was considered by WRC in its 154<sup>th</sup> meeting held on sept. 11-12, 2011 and the committee decided that show cause notice under section 14 (3) (B) of the NCTE Act, 1993 be issued to the institution on the following points:-

- The society has applied for another college with the name of Iqra Urdu D.Ed. College at the same premise and in the building at survey No. 45.
- Built up area of 1758 sq. mts. Is inadequate.
- As per CLU dated 31.04.2007 diverted area is 2000 sqm which is not sufficient for two colleges.
- Multipurpose hall is small.

And whereas, the show cause notice issued to the institution on 18.10.2011. along with supporting documents.

And whereas, the matter was placed in 159<sup>th</sup> WRC Meeting held on February 7-9, 2012 and the committee came to the conclusion that recognition for the proposed course to the said institution be refused under section 14 (3) (b) of NCTE Act, 1993 on the following grounds:-

- On seeing the file of this institution along with other file No. 123835 ( Jay Hind Marathi B.Ed. College), it was found that the institution has submitted the same building plan for the same area. The area required under the Regulation is less for D.Ed. course.

And whereas, the refusal order was issued to the institution on 29.03.2012.

And whereas, the institution had preferred an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993, the Appellate Authority vide order dated 17.08.2012 accepted the appeal and remanded the matter to the WRC for further consideration as per Regulations.

And whereas, the matter was placed before the WRC in its 172<sup>nd</sup> meeting held on 13-15 October, 2012 and the committee decided that the WRO should process the case in the light of the Appeal Order and put up for decision before committee.

And whereas, the matter was placed before the WRC in its 179<sup>th</sup> meeting held on 11-13, February 2013. The committee decided that the WRO is directed to see the application of this Society.

And whereas, the matter was placed before WRC in its 181<sup>st</sup> meeting held on 18-20 March, 2013. The committee decided that show cause notice be issued to the institution on the following points:-

- Land and built up area is sufficient for one course. It is seen that the inspection has not submitted originally notarized building completion certificate. Also the institution does not hav the facility for language lab.
- The VT which visited the institution on 31.07.2011 found the number of encyclopedias and journals very less.
- As per the building Plan, the total built up area is 969.75 sq. mtrws while the VT has mentioned the built up area as 1758 sq mtrs., while the management letter dated 14.11.2011 says that the built up area is 2000 sq. mtrs

And whereas, Show Cause Notice issued to the institution on 09.04.2013

And whereas, the institution submitted reply dated 08.04.2013

And whereas, the matter was placed before WRC in its 184<sup>th</sup> meeting held on 27-29, May 2013. The committee decided that to obtain views in the context of Demand & Supply to the State Govt. of Maharashtra.

"... Demand & Supply letter was issued to the Govt. of Maharashtra on 01.07.2013. The institution has not replied to the Govt. of Maharashtra.

And whereas, the matter was placed before WRC in its 266<sup>th</sup> meeting held on June 10-12 2017, and the Committee decided as follows:-

"... Clarification letter/Show Cause Notice dt. 01.07.2013 was issued to the institution reply has not been received till date.

**Hence, Recognition is refused."**

Now, therefore, in exercise of the powers vested under section 15(3)(b) of NCTE Act, 1993, the Western Regional Committee hereby refuses permission to Iqra Urdu D.Ed.College, Plot No. 3385, Survey No. 45, Opp. Market Committee, Bahirwadi, Beed-224738, Maharashtra for conducting the B.Ed. Programme.

Further, if the institution is not satisfied by the order, they may prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 online against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order.
