REFUSAL ORDER

Whereas, In terms of section 14(1) of the NCTE Act, 1993, MATOSHRI SHIKSHAN SEVA MANDAL, LATE YASHWANTRAO DESHMUKH ADHYAPAK VIDYALAYA (D.ED.), SURVEY NO.132, VILLAGE-KAVTHAL TAH.-MANGRULPIR, DIST.-WASHIM-444103, MAHARASHTRA(APW04055/1221407). had applied on 15.11.2006 to the Western Regional Committee, NCTE, Bhopal, for grant of recognition to start D.ED (M) (CO-ED) course with an intake of 50 seats.

And whereas, in the light of NCTE Hqrs. letters F.No.46-3/2008/NCTE(N&S)/84003 dt. 17 Sep, 2008, F.No. 49-27/2007/NCTE(N&S) dt. 1 October, 2008 and F.No. 49-27/2007/NCTE(N&S) dt. 31 October, 2008 received from Member Secretary, NCTE, New Delhi and negative recommendation received from the Maharashtra State Govt. in respect of D.Ed. Course, the WRC in its 110th WRC meeting decided that "no further processing will be done in this case and communication to this effect to be made to the institution." The decision of WRC was conveyed vide letter No. APW04055/122884/110th/SCN/2008/52405 dated 07.03.2009 to the institution.

And whereas, the institution had filed a WP No.7008 of 2009 before the Hon'ble High Court of Judicature at Bombay and the Hon'ble High Court had passed order dated 11.06.2010 in the said W.P.

And whereas, the application was considered by WRC in its 145th meeting held on February 17-18, 2011 and the Committee decided to constitute inspection team.

And whereas, the inspection of the said institution was conducted by visiting team on 25.04.2011. The report of the visiting team was considered by WRC in its 150th meeting and the Committee decided to issue Show Cause Notice on the following points :-

- ***The Lab facilities are inadequate.***
- ***One Classroom on the 1st floor is roofed and partitioned by aluminium sheets.***

And whereas, the applicant institution did not submit any representation in respect of the aforesaid show cause notice. The matter was again considered by the Western Regional

Committee in its 155th Meeting held on 18th to 20th Oct., 2011 which came to the conclusion that permission to the said institution be refused for the following reasons :-

- **Matoshri Shikshan Seva Mandal has not responded to the Show Cause Notice dt. 21.06.2011.**

Now, therefore, in exercise of the powers vested under section 14(3) (b) of the NCTE Act, 1993, the Western Regional Committee hereby refuses the recognition sought by Matoshri Shikshan Seva Mandal, Late Yashwantrao Deshmukh Adhyapak Vidyalaya (D.Ed.) Survey No. 132, Village- Kavthal, Tah- Mangulpir, Distt.- Washim - 444103, Maharashtra for conducting the D.ED. (M) (CO-ED) course.

Further, if the institution is not satisfied by the order, it can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.

AND WHEREAS, WRC considered the case of the institution in light of letters F.No.46-3/2008/NCTE(N&S)/84003 dt. 17 Sep, 2008, F.No. 49-27/2007/NCTE(N&S) dt. 1 October, 2008 received and F.No. 49-27/2007/NCTE(N&S) dt. 31 October, 2008 from Member Secretary, NCTE, New Delhi and negative recomanodation received from Maharashtra State Govt. in respect of D.Ed. Course. Keeping in view of the negative recommendation received from the Maharashtra State Government in respect of D.Ed. course and directions received from NCTE Hqs, the WRC decided that no further processing will be done in this case and communication to this effect to be made to this institution.

4. NOW THEREFORE, as per above decision taken by WRC, the proposal of said institution is to be treated as closed, the FDRs towards Endowment Fund (in original) is returned herewith.
