Sir,

I am directed to say that SHRI RAM COLLEGE OF EDUCATION, KHASRA NO. 119/2,120/3 121/2, 166/1 120/1, PLOT NO. 119,120, 121, 166, BARAUA, POST BARAUA, GWALIOR MADHYA PRADESH has applied for grant of recognition/permission for conducting D.EL.ED course to Western Regional Committee on 07.10.2010.

2. The Western Regional Committee had constituted a Visiting Team to visit the institution, which has visited the institute on 12.09.2011 and have submitted its report. Upon consideration of the report submitted by the visiting team, perusal of videography and other materials furnished by the institution along with the application, the Committee is of the opinion that the institution does not fulfill the norms and standards and other requirements laid down and notified by the NCTE in accordance with the provisions of the NCTE Act, 1993, the details of which are mentioned below:

- a) The name of the college is not written in bold letters with oil paint on the front side of the building legibly.
- b) The name of the college is not written with oil paint permanently on the pieces of furniture and other equipments.
- c) Journals are not subscribed.
- d) The list of psychology tests was not provided to the VT.
- e) The computer lab doesn't have facilities for internet and CD ROMs.
- f) The college has not developed its own website.
- g) The playground is not developed.
- h) The boundary of the college has not been earmarked. In the east there is SSB College of Education (WRCAPP1108), in the West there is open field and in the South is Pratap Institute of Professional Studies and in the North there is open field.
- i) Library has only 20 chairs.
- j) Labs like psychology, computer, ET. do not have adequate number of seats and equipments.
- k) The multipurpose hall does not have a mike-set.
- l) Fans and other electric fitting are to be completed.
- m) Electricity connection has not been obtained so far.

3. Before the Western Regional Committee passes an order for refusal of recognition to the institution u/s 14/15 of the NCTE Act, you are hereby given an opportunity under Section 14/15 (3)(b) of NCTE Act, 1993 for making your written representation.
