RECOGNITION ORDER

AND WHEREAS, the institution, **MA SIDDHESWARI EDUCATION COLLEGE, KHASRA/PLOT NO.535, VILLAGE - KALAMAD BAIRAD, POST OFFICE - BAIRAD, TEHSIL/TALUKA - POHARI, TOWN/CITY - BAIRAD, DISTRICT - SHIVPURI, PIN CODE - 473793, MADHYA PRADESH (WRCAPP1539)** has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **248th meeting held on April 11-12, 2016** was satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **D.El.Ed.** programme, such as infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to **MA SIDDHESWARI EDUCATION COLLEGE, KHASRA/PLOT NO.535, VILLAGE - KALAMAD BAIRAD, POST OFFICE - BAIRAD, TEHSIL/TALUKA - POHARI, TOWN/CITY - BAIRAD, DISTRICT - SHIVPURI, PIN CODE - 473793, MADHYA PRADESH** for conducting **D.El.Ed.** programme of 2 (Two) years duration with an annual intake of **50 students (one basic unit)** from the academic session **2016-2017**.

The institution shall comply with various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.



The recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.
