REFUSAL ORDER

Date: 01/02/16

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, PT. BRIJ BHADUR TIWARI JANKALYAN SAMITI, PLOT NO. - 69, PANNA ROAD, VILLAGE + P.O. + TEHSIL + DIST. - CHHATARPUR - 471001, MADHYA PRADESH had submitted the online application on 29/12/2012 to the Western Regional Committee of the NCTE for grant of recognition to A S MAHAVIDYALAYA CHHATARPUR, PLOT NO.- 69, PANNA ROAD, VILLAGE - ACHATTA, P.O. + TEHSIL + DIST.- CHHATARPUR - 471001, MADHYA PRADESH for starting the B.ED. course.

AND WHEREAS, the application of the institution was processed.

AND WHEREAS, Deficiency letter issued to the institution on 18.06.2013 and reply was submitted on 13.08.2013.

AND WHEREAS, the matter was placed before WRC in its 190<sup>th</sup> meeting held on September 18-20, 2013 and the Committee decided that "...In response to the deficiency letter dated 18.06.2013, the institution has submitted all the documents, which are in order.

Hence, VT be constituted."

AND WHEREAS, C.L.U order letter issued to the institution on 18.10.2013 and reply was submitted on 28.10.2013 and C.L.U. order issued to the SDO Chhatarpur on 18.10.2013 and reply was submitted on 13.11.2013.

AND WHEREAS, the matter was placed before WRC in its 193<sup>rd</sup> meeting held on November 11-13, 2013 and the Committee decided that "...The office has pointed out that after issue of DL, documents were submitted by the Society were examined. It was seen that the CLU submitted alongwith the documents is not acceptable because it is an order which says that since the Society has constructed on a land which was not diverted and has not deposited the diversion/penal fee, the Revenue Authority does not consider the land as diverted. The WRC noticed that apart from the issue relating to the CLU, there is no comment from RD/WRO whether there is any lacunae under the NCTE regulations, 2009, in the other documents. Hence, the RD/WRO is directed to study all the documents and put up the case before WRC for decision."

AND WHEREAS, the AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 issued to the institution on 24.12.2014 and the reply was not received.

AND WHEREAS, the matter was placed before WRC in its 225<sup>th</sup> meeting held on May 14, 2015 and the Committee decided that "...Deficiency Letter dated 18.06.2013 was issued. The case was seen in the 193<sup>rd</sup> meeting (November 11-13, 2013). It was noticed that the applicant has not submitted the CLU. The WRO issued a letter dated 24.12.2014 for submission of an Affidavit consenting to function under NCTE Regulations, 2014. No response is there from the applicant.

Hence, Show Cause Notice be issued on the following grounds:-

- (i) Non-submission of proper CLU;
- (ii) Non-submission of Affidavit;
- (iii) As per building completion certificate, built up area is less than required; and Non-submission of FDR amounting to Rs.4.00 lakhs.."

AND WHEREAS, Show Cause Notice issued to the institution on 22.05.2015 and reply not submitted.

AND WHEREAS, the matter was placed before WRC in its 240<sup>th</sup> meeting held on January 20-22, 2016 and the Committee decided that "... Show Cause Notice dt. 22/05/2015 was issued on the grounds of :-

- i) Non submission of CLU;

- ii) Non submission of Affidavit consenting to function under NCTE Regulations, 2014;
- iii) Less built up area; and
- iv) Non submission of balance FDRs amounting Rs. 4 lakhs.

Since no reply has been received till date. **Hence, Recognition is refused.**

The remaining FDRs be returned."

Now therefore, the WRC, in exercise of the powers vested under section 14(3)(b) of the NCTE Act, 1993, hereby refused recognition to, **A S MAHAVIDYALAYA CHHATARPUR, PLOT NO.- 69, PANNA ROAD, VILLAGE – ACHATTA, P.O. + TEHSIL + DIST.- CHHATARPUR – 471001, MADHYA PRADESH** for **B.ED.(CO-ED)** course.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order though online, using website [www.ncte-india.org](http://www.ncte-india.org).
