Restoration of Recognition Order

Whereas, recognition was granted to the institution namely SHRI AMULBA MAHILA B.ED. COLLEGE, A.P.M. SHOPPING MALL CENTER (BASEMENT), GHATLODIA, AHMEDABAD, GUJARAT, for conducting B.Ed. course vide order no. No. WRC/5-6/99th/2007/C - 20106 - 20113 dt. 25.07.2007.

And whereas, on the direction of the NCTE HQrs vide letter no. 49-8/2008/NCTE/(N&S)/78627 dt 21.05.2008 from NCTE. New Delhi directing WRC to conduct the impertion of 129 colinges of Emjaratur's 17 or the NCTE Act 1993, as per the observation of Principal A.U.Patel, the Chairmen, fee/admission committee for self finance B.Ed. /B.P.Ed. course Gujarat State & Formal Vice - Chancellor, Gujarat University. The Western Regional Committee had constituted de Visiting Team u/s 17 of NCTE Act, 1993 to visit the institution.

And whereas, the inspection was conducted on 09.06.2008.

And whereas, the matter was considered by WRC in its 104th meeting. As per Committee decision Show Cause Notice issued to the institution on 04.08.2008.

And whereas, the matter was again considered in 110th meeting of WRC. Committee decide withdrawn recognition for B.Ed. course. The withdrawal order issued vide letter no WRC/APW04968/323507 (GIRLS)/110th/2008/48626 dt 22.12.2008.

And whereas, institute has filed an appeal before the Appellate Authority at NCTE. New Delhi and Appellate Authority vide order Ino. 89-60/2009/Appeal/ dt. 21 05.2009 has remanded back the matter to WRC for re-examination of the matter in the light of Council's observations and for taking decision thereafter.

Thereafter institution has filed a writ no. SCA no. 5731 of 2009 before the Hon'ble High Court of Gujarat. Institution has again filed a writ no. SCA no. 7835 of 2011 dt 27.12.2011 before the Hon'ble High Court of Gujarat.

And whereas, the matter was placed in 145th meeting of WRC as per decision the institution failed to deposit Demand draft Rs. 10000/- with communication send to the VT. As per the Court direction the recognition automatically stands withdrawn without passing any order. The concerned institution and the University be intimated accordingly.

And whereas. VT constituted in compliance to Ho'ble Court Order dt. 27.12.2011. The Ho'ble Court vide their Order dt. 27.12.2012.

And whereas, VT visited in the institution on 24.03.2012. VT report placed in 166th meeting of WRC, as per decision the Show Cause Notice to be issued u/s 17 of NCTE Act. Show Cause Notice issued to the institution on 22.08.2012.
