Whereas permission was granted to PRAGATI COLLEGE, CENTRAL VENUE, CHOUBEY COLONY, RAIPUR-492001, CHATTISGARH under section 15 of NCTE Act, 1993 for conducting D.Ed course with an annual intake of 50 students vide WRC order No.WRC/2-32/722020/66/2004/8506-07 dated 10.10.2004.

And whereas, upon consideration of the inspection report cause under section 17 of NCTE Act with other relevant materials furnished by the institution along with the application and otherwise in the 134th meeting of WRC where WRC decided to withdraw recognition under section 17 of the NCTE Act for the D.Ed course.

And whereas the correspondent, PRAGATI COLLEGE, CENTRAL VENUE, CHOUBEY COLONY, RAIPUR-492001, CHATTISGARH, has preferred an appeal to NCTE New Delhi against the decision of WRC withdrawing recognition under section 17 of the NCTE Act, 1993 against the said order.

And whereas the Appellate Authority at NCTE, New Delhi accepted the appeal vide order F.No.89-618/2010-Appeal dt. 01.09.2010 and remanded the case to WRC for taking the decision, with regard to D.Ed. course, in light of the recognition extended by WRC for B.Ed. and M.Ed. programmes offered by the same institution.

Now therefore, in compliance to appeal order dt. 01.09.2010, the permission of said institution for D.Ed course is hereby continue with the same terms and conditions as mentioned in the recognition order dated 10.10.2004.

WHEREAS recognition was granted to the institute PRAGATI COLLEGE CENTRAL AVENUE CHAUBEY COLONY, RAIPUR- 492001, CHATTISGARH under section 14 of NCTE Act, 1993 for conducting D.ED. course with an intake of 50 vide order No.WRC/2-32/722020/66/2004/8506-07 dated 10.10.2004.

- WHEREAS on the basis of complaint received against institution, the Western Regional Committee had constituted a visiting team u/s 17 of NCTE Act, 1993 to visit the institution.
- 3. AND WHEREAS, the matter was considered by the WRC in its 132ND meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-
 - 1. The built up areas for the various courses run by the college namely D.Ed. (100), B.Ed. (100), M.Ed. (25), PGDCA, alongwith B.Com, B.A. not earmarked.
 - 2. Registered land document not submitted.
 - 3. Approved building plan not submitted.
 - 4. AND WHEREAS, the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 25/03/2010.
 - AND WHEREAS, institution has submitted the reply in response to show cause notice on 19/04/2010.
 - 6. AND WHEREAS, the matter was again considered by the Committee in its 134^{TE} meeting held or Man 05-06, 2010 and having taken into consideration all the relevant facts of the case, it was decided to withdrawn recognition for conducting **B.ED**, course on the following grounds.
 - 1. The institution is not having land on ownership basis. The document submitted by the institution is of only rent deed of the building.

2. Approved building plan not submitted.

- 3. Built up are for D.Ed., B.Ed., and M.Ed., is not carmarked.
- 7. NOW, THEREFORE, in exercise of powers vested to Western Regional Committee under section 17 (1) of NCTE Act, 1993, the recognition grant is to PRACATI COLLEGE CENTRAL AVENUE CHAUBEY COLONY, RAIPUR- 492001, CHATTISGARH for D.Ed course is hereby withdrawn from the end of the academic session next to the following date of this withdrawal order on the grounds mentioned above.
