#### **Revised Order**

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the Royal College, Lalbagh, District- Rajnandgan, Chhattisgarh- 491441 by affidavit dt. 23.01.2015 has consented to come under new Regulations and sought for two basic units in **B.Ed.** which require additional facilities
- 3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
  - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Royal College, Lalbagh, District- Rajnandgan, Chhattisgarh- 491441 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

a) Sanctioned programmes along with annual intake in the institution:

b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.

Name of faculty members who left or joined during the last, quarter:

Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;

Available infrastructural facilities;

g) Facilities added during the last quarter;

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter,

i) The affidavit with enclosure submitted along with application.

j) The institution shall be free to post additional relevant information, if it so desires.

Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. Recognition order no. WRC/5-6/120<sup>th</sup>/2009/57169-57174 dated 06.07.2009 be treated as cancelled from the date of issue of this revised order.

## **Recognition Order**

- 2. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to ROYAL COLLEGE, LALBAGH, RAJNANDGAON-491441, CHATTISGARH for conducting B.ED. course of SEC of 1 year duration with an annual intake of 100(SEC) from the academic session 2009-2010 under clause 7(11) of NCTE( Recognition Norms & Procedure ) Regulation 2007.
- 4. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
- 5. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- 6. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
  - 7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
  - 8. Further, subject to the provision of NCTE Act 1993, the institution shall fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, applicable.
  - 9. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, I, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. 

### Rejection Order

A visit of the applicant institution was carried out on 08/03/2007 by a visiting team constituted by the Regional Committee, NCTE.

AND WHEREAS the Regional Committee, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had opined that the applicant institution does not fulfill the requirements.

AND WHEREAS the applicant institution had submitted representation dated 15/06/2007. The Regional Committee, after considering the reply of the institution and report of the visiting team as well as other relevant materials furnished by the applicant institution, had opined that the applicant institution does not fulfill the requirements and issued a notice to the applicant institution under provision to section 14 (3) (b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation on this behalf.

AND WHEREAS the applicant institution had submitted the reply on 15/06/2007. The visiting team report and the said reply of the institution as well as other documents and materials submitted were duly considered by the Regional Committee in its 99th meeting held on July 19<sup>th</sup>-22<sup>nd</sup>, 2007 which came to the conclusion that recognition to the said institution be refused for the following reasons:-

- 1. Staff details not proper and not qualified as per NCTE norms.
- 2. Size of rooms & hall not as per NCTE norms
- 3. Facilities for language learning are not available.

NOW. THEREFORE, it is hereby ordered that recognition to conduct **B.ED.** course is, therefore, refused to the institution for the academic session 2006-2007.

Also ordered that a copy of this order be published in the Official Gazette.
