AND WHEREAS, as per clause 7(2) of the NCTE Regulation, 2009 a copy of the application was sent on 13-03-2013 to the State Govt, of Madhya Pradesh for their views/ recommendations on the application.

The Commissioner, Rajya Siksha Kendra & Secretary M.P. Govt. School Education Department, vide letter no. 2086 dated 24-06-2013 has informed that in Neemach district already 06 private institutions are conducting the D.Ed./ D.El.Ed. courses. Hence, opening of new course has not been recommended in Neemach district. This was in compliance of their policy matter as per letter No. 134/1537 / School Education /2012 dated July 23, 2012.

AND THEREAFTER, the letters received from the Govt. of M.P. were placed before WRC in its 187th meeting held on 25-26th July, 2013. The committee decided and gave there comments as under

"The Rajya Shiksha Kendra through State Government of MP's opinion has advised that since there are already 06 teacher training institutions in Neemuch district, it does not need any fresh institution for running D.El.Ed. teacher training institutions since sufficient teachers are available.

Since, the State Government has not recommended the case and as per directions received from the NCTE hqrs letter No.49-7/2012/NCTE/N&S dated 20.03.2013 following the Hon'ble Supreme Court directions received vide order dated 06.01.2012 in Civil Appeal No.104 of 2012 arising out of SLP (C) No.14020 of 2009, this application is rejected."

NOW. THEREFORE, since the Govt, of Madhya Pradesh has given negative recommendation for opening of new D.EL.ED. college/ increase in intake in D.EL.ED. course, application of your institution is hereby rejected.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan Wing II, I, Bahadur Shah Zafar Marg, Near ITO, New Delhi 110002 against this order Under Section 18 of the NCTE Act 1993 within 60 days of the issue of this order.
