ORDER

The Institute SHRI VAISHNAV VIDYAPEETH TRUST, PLOT NO. - SCH NO. 71, GUMASTA NAGAR, P.O. - SUDAMA NAGAR, TEHSIL + DIST. - INDORE , CITY - INDORE - 452009, MADHYA PRADESH submitted the on line application dated 31-12-2012 for seeking grant of recognition/permission to SHRI VAISHNAV COLLEGE OF TEACHERS TRAINING, PLOT NO. - SCH NO. 71, STREET NO. - 71, P.O. - SUDAMA NAGAR, TEHSIL + DIST. - INDORE, CITY - INDORE - 452009, MADHYA PRADESH, for D.El.Ed. course.

AND WHEREAS, as per clause 7(2) of the NCTE Regulation, 2009 a copy of the application was sent on 05-04-2013 to the State Govt. of Madhya Pradesh for their views/ recommendations on the application.

The Commissioner, Rajya Siksha Kendra & Secretary M.P. Govt. School Education Department, vide letter no. 1568 dated 16.05.2013 has informed that in Indore district already 22 private institutions are conducting the D.El.Ed/ D.El.Ed. courses. Hence, opening of new course has not been recommended in Satna district. This was in compliance of their policy matter as per letter No. I34/1537 / School Education /2012 dated July 23, 2012

AND THEREAFTER, the letters received from the Govt. of M.P. were placed before WRC in its 184th meeting held on 27-29th May, 2013. The committee decided and gave there comments as under

"The case file was seen. As per clause 7(2)(3) of NCTE Regulations, 2009, it is mandatory to request the concerned State Government to give their opinion/ recommendation on the opening of a teacher education course in private institutions. This Regulation has been further confirmed by the Hon'ble Supreme Court vide its judgment dated 31.01.2011 in SLP No.17165-168/2009. The ruling in this case has been reiterated in the letter No.49-7/2012/NCTE/N&S dated 20.03.2013, of the Member Secretary, NCTE Hqrs. In the present case, the Society - Shri Vaishnav Vidyapeeth Trust, Indore had applied for increase in intake in the existing D.El.Ed. (Co-Ed) course in Shri Vaishnav College of Teachers Training, Indore. The State Government through the Rajya Shiksha Kendra vide their letter No.1568 dated 16.05.2013 has informed that in Indore district already 22 private institutions are conducting the D.El.Ed/ D.El.Ed. courses. Hence, opening of new course has not been recommended in Indore district."

"The application cannot be considered for Recognition. Hence, it is rejected."

NOW, THEREFORE, since the Govt. of Madhya Pradesh has given negative recommendation for opening of new D.EL.ED. college/ increase in intake in D.EL.ED. course, application of your institution is hereby rejected.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan Wing II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi 110002 against this order Under Section 18 of the NCTE Act 1993 within 60 days of the issue of this order.
