REFUSAL ORDER

963, 964, 965, 966, 967, 968, 969

WHEREAS in terms of section 14 of the NCTE Act, 1993, **SHREE BALDEV PRASAD SHARMA SAMAJIK SANSTHA, SAMITI, VILLAGE: NINORA, STREET/ROAD: INDORE ROAD, TALUKA/MANDAL: NINORA, TOWN/CITY: UJJAIN, DISTRICT: UJJAIN-456006, MADHYA PRADESH** had submitted the application on **30.06.2016** to the Western Regional Committee of the NCTE for grant of recognition to **RUDRA INSTITUTE OF HIGHER EDUCATION, VILLAGE: NINORA, STREET/ROAD: INDORE ROAD, TALUKA/MANDAL: UJJAIN, TOWN/CITY: UJJAIN, DISTRICT: UJJAIN-456006, MADHYA PRADESH** for conducting the **B.Sc.B.Ed. 4 Years integrated programme**.

AND WHEREAS, as per clause 7(4) of NCTE Regulations, 2014, letter to State Government was issued on 16.08.2016 requesting to give their recommendation/comments.

AND WHEREAS, the matter was placed before the WRC in its 270th meeting held on March 1-3, 2017 and the Committee decided that "...The institution has applied for the B.Sc.B,Ed course for 100 seats and B.A.B.Ed. course for 100 seats. As per the NCTE Hqrs. communication, this is only one course and hence, does not satisfy clause 2(b) of the NCTE Regulations, 2014. Further, the land of the Society is on private lease which is not permitted. Non-Encumbrance Certificate and the latest premium receipt for the CLU are also not submitted. **Hence, Show Cause Notice be issued on the above grounds. Reply should be submitted within 30 days.**"

AND WHEREAS, the Show Cause Notice was issued on 09.03.2017 through online.

AND WHEREAS, the matter of reply not received was placed before WRC in its 279th meeting held on August 10-11, 2017. The Committee decided that "...Show Cause Notice/ Clarification letter was issued on 09.03.2017. Till date no reply has been received. **Hence, Recognition is refused. FDRs, if any, be returned.**"

NOW, THEREFORE, the WRC, in exercise of the powers vested u/s 14 (3) (b) of the NCTE Act, 1993 hereby refuses Recognition to **RUDRA INSTITUTE OF HIGHER EDUCATION, VILLAGE: NINORA, STREET/ROAD: INDORE ROAD, TALUKA/MANDAL: UJJAIN, TOWN/CITY: UJJAIN, DISTRICT: UJJAIN-456006, MADHYA PRADESH** for the **B.Sc.B.Ed. 4 - Years** integrated programme.

FURTHER, if the institution is not satisfied by the order, it can prefer an appeal to the National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi - 110002 against the order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order through online mode, using website www.ncte-india.org.
