WHEREAS, WRC, NCTE had granted recognition/permission to RAJEEV GANDHI COLLEGE OF EDUCATION, HOSHANGABAD ROAD, OBEDULLA GANJ, RAISEN, MADHYA PRADESH vide order dated 15.12.2006 to start the B.ED. (CO-ED) course with an annual intake of 100 students.

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015. The institution submitted affidavit vide letter dated 18.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units (each 50 students) to the institution on 31.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition mentioned in revised order."

AND, WHEREAS, a Show cause notice was issued to institution on 10.08.2016 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure.

AND WHEREAS, a letter was submitted by the institution on 17.11.2016 with a request & affidavit for closure of one unit of B.Ed. course from the academic session 2016-17.

AND WHEREAS, the matter was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that "... Institutions which have requested for reducing intake may be permitted."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce the intake of 100 students (2 basic units) to 50 students (one unit.)

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the RAJEEV GANDHI COLLEGE OF EDUCATION, HOSHANGABAD ROAD, OBEDULLA GANJ, RAISEN MADHYA PRADESH by affidavit date 08.01.2015 has consented to come under new Regulations and sought for two basic units in **B.Ed**, which require additional facilities.
- 3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely:-
 - I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/aiready submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating-body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to RAJEEV GANDHI COLLEGE OF EDUCATION, HOSHANGABAD ROAD, OBEDULLA GANJ, RAISEN MADHYA PRADESH for conducting B.Ed programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter:

j) The institution shall be free to post additional relevant information. If it so desires.

k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

(b) The institutions shall note that with regard to NET / SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.7.2006.

(c) The institutions shall adhere to all the other regulations and guidelines as framed by

NCTE from time to time.

(d) The institutions shall within one month of the receipt of the Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.

(e) That the Reserve fund for an amount of Rs. Three Lakhs be maintained in the form of FDR

in favour of the managements / institutions

(f) Further, the recognition is subject to talifilment of all such other requirements as may be

prescribed by other regulatory bodies like UGC and State Government etc.

(g) The institutions shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

(h) The institutions shall regularly update their website.

- (i) The institutions intending to run the teachers training programme approved above in a rented premises are required to submit report in compliance of the requirement of NCTE Regulations on the subject regarding their shift to permanent building.
- 5: If any of the institutions contravene any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act 1993. The NCTE Hors. May also cause inspections under Section 13 of NCTE Act, 1993.
- 6. It is mandatory for the institutions to complete 180 teaching days as such the concerned university/board should ensure the recognition granted as per NCTE regulations and if the recognition date did not match with the academic calendar then the recognition granted shall be effective from the ensuing academic session.
