RESTORATION ORDER

WHEREAS, the institution, namely, SHRI DWARIKA PRASAD YADAV SHIKSHA MAHAVIDYALAYA, BRIJ COLONY, SIRONJ, VIDISHA, MADHYA PRADESH was granted recognition by WRC, NCTE for **B.Ed.** Course of one year duration with an annual intake of **100** students vide order No. WRC/APW01976/223400/152nd/B.Ed./2011/81755-81761 dated 23.09.2011.

- 2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution viz. SHRI DWARIKA PRASAD YADAV SHIKSHA MAHAVIDYALAYA, BRIJ COLONY, SIRONJ, VIDISHA, MADHYA PRADESH for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 vide order No. WRC/APW01976/223400/2015/149229-9236 dated 31.05.2015.
- 3. AND WHEREAS, as per decision of WRC taken in its 314th meeting said recognition was withdrawn of the institution and withdrawal order was issued to the institution vide order No.WRC/APW01976/223400/B.Ed./314th/2020/208758-765 dated- 05.08.2020.
- 4. **AND WHEREAS**, meanwhile the institution has filed W.P. (C) 9965/2020. In the High Court of Delhi at New Delhi. The Hon'ble High Court of Delhi passed an order dated 08.12.2020. The matter was considered by WRC in its 343rd meeting held on 08th to 09th October, 2021 and committee decided that In compliance of the order passed by the Hon'ble High Court of Delhi vide W.P.(C) 9965/2020 dated 08.12.2020, were carefully considered by WRC and the Committee decided to advise the institution to prefer appeal under Section 18 of the NCTE Act 1993 for further course of action. Accordingly, letter was issued to the institution vide letter no. F.No.WRC/NCTE/ APW01976/223400/B.Ed./243rd/2021/218066 dated 27.10.2021.
- 5. **AND WHEREAS,** institution had filed an appeal before the council (NCTE) under section 18 of NCTE Act, 1993. The Appellate Authority vide its order dated 12.07.2022 remanded back the case to the WRC, NCTE. The institution submitted the reply/documents in response to Appellate Authority order.
- 6. **AND WHEREAS,** in the light of order dated 12.07.2022 passed by the Appellate committee the case was considered by WRC in its 400th Meeting held on 13th February, 2024 and WRC decided as under:-
- "In compliance of the order of the appellate authority and the order dated 30.07.2021 of the Hon'ble High Court of Delhi in W.P. 7260/2021titled as "Arihant College and Anr. V NCTE" the recognition of the institution be restored pending further consideration by the WRC.
