Order for Shifting of Premises

WHEREAS, the institution namely SAKESHWAR GRAMIN VIKAS SEVA SANSTHA, AT GRUKUL, LAL TAKI ROAD, POST-SAVEDI, TAL-AHMEDNAGAR/DIST- AHMEDNAGAR, MAHARASHTRA was granted recognition by WRC, NCTE for B.Ed. (M) (CO-ED) Course with an annual intake of 100 Students vide order No. WRC/5-6/101/2008/C-29041 dated 07.02.2008.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No. WRC/APW03989/123473/2015/149828- 9835 dated 04.08.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

3. AND WHEREAS, As per decision taken by WRC in its 391st meeting the name of the institution was changed. vide order No. NCTE/WRC/APW03989/123473/B.ED./391st/M.H/2023/223822-223828 dated 07.08.2023 from Sakeshwar Gramin Vikas Seva Sanstha to Adsul B.Ed. College.

4. AND WHEREAS, the institution submitted application for shifting of premises on 27.04.2023.

5. AND WHEREAS, as per the decision taken by WRC in its 391st Meeting held on 3-4 August 2023, the inspection was conducted on 28.08.2023 for shifting of premises.

6. AND WHEREAS, the matter was considered by the WRC in its 395th meeting held on 25th September, 2023 a Show Cause Notice was issued to the institution on 29.09.2023 and its reply submitted by the institution on 04.10.2023.

7. AND WHEREAS, the reply was placed before WRC in its 396th meeting of WRC held on 6th October, 2023 and Committee decided that the institution be permitted to shift its B.Ed. Course in new campus/building situated at "Gata No. 64+65+75p+1084p, Chas-Nimbalk Bypass Road, Chas, Tal. & Dist. Ahmednagar, Maharashtra.

8. NOW THEREFORE, in exercise of the powers vested under section 14(3)(a) of NCTE Act, 1993, the permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted to Adsul B.Ed. College for Shifting of premises from at Gurukul, Lal Taki Road, Post-savedi, Tal. & Dist. Ahmednagar-414001, Maharashtra to Gata No. 64+65+75p+1084p, Chas-Nimbalk Bypass Road, Chas, Tal. & Dist. Ahmednagar, Maharashtra with immediate effect for conducting its 2 year B.ED Course.
