RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to **MODERN TEACHERS TRAINING GIRLS COLLEGE, AKASHWANI ROAD, SAINIK BASTI, DISTRICT-CHURU RAJASTHAN-331001** under section 14 (3)A of NCTE Act, 1993 for conducting D.El.Ed. course (50 Intake) vide order No. NRC/NCTE/F-7/RJ-777/2007/24812-18 dated 17.08.2007.

2. **AND WHEREAS**, the matter was placed in 316TH Meeting of WRC held on 27-28, August and 3 September, 2020 and the Committee decided that

"...The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

3. **AND WHEREAS**, the matter was again placed in 321ST Meeting held on 09-11, November, 2020 of NRC and the Committee decided that:

"...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

1. Recognition was granted to the institution on 17.08.2007 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.
2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Notice was issued to the institution on 30.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of STC programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-22."

4. **AND WHEREAS**, the Withdrawal Order was issued to the Institution on 14.12.2020.

5. **AND WHEREAS**, the institution filed an Appeal to the Council on 09.01.2021 and the Council vide its order dt. 18.03.2021 remanded back the case to the WRC, NCTE for necessary action.

6. **AND WHEREAS**, the institution had approached the Hon'ble High Court of Delhi At New Delhi, in W.P. (C) No. 11437/2021 dt. 06.10.2021 the operative part is produced here below:-

"...In the present case, the petitioners have placed on record a representation dated 14.08.2021 citing the judgment in Arihant College (Supra) and requesting the WRC to

issue the order of restoration of recognition..." to comply with request, which has compelled the petitioners to institute the present petition.

7. **NOW THEREFORE, recognition of the institution viz MODERN TEACHERS TRAINING GIRLS COLLEGE, AKASHWANI ROAD, SAINIK BASTI, DISTRICT-CHURU RAJASTHAN-3310001 for D.EL.ED. course with an annual intake of 50 students (one unit) is hereby restored .**
