RESTORATION ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely COLLEGE OF EDUCATION VISHWAMANGALAM KELAVANI MANDAL, HIMATNAGAR, VISHWAMANGALAM KELAVANI MANDAL, HIMATNAGAR, DIST. SABARKANTHA., SABARKANTHA., Gujarat vide order No. WRC/2-32/323157/2005/4810 dated: 24.06.2005 and /5-6/106th /2008/40262 dated: 28.08.2008 for conducting B.Ed. (CO-ED) course with an annual intake of 200 students.

2. **AND WHEREAS**, the Revised Recognition order was issued to the institution vide dated 12.08.2015 for B.Ed. course with an annual intake of 200 students with a direction to submit the compliance to the Revised Recognition order on or before 31.10.2015.

3. As no compliance to the revised recognition order was received, the matter was considered by WRC in its 255th meeting and as per the decision of WRC, Show Cause Notice for non-submission of compliance was issued vide dated: 02.09.2016.

4. The institution has not submitted any reply to the Show Cause Notice dated 02.09.2016. The matter was considered by WRC in its 279th meeting, wherein the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the next academic session following the date of communication of the said order.

Accordingly, withdrawal order was issued to the institution on 18.08.2017.

5. **AND WHEREAS**, The institution has filed an Appeal vide no. F.No. 89-753/E-52343/2017Appeal/10th Mtg.-2018/25th & 26th May, 2018/67795 dated: 12.07.2018 and the committee decided as under: -

After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Committee concluded that the matter deserved to be remanded to W.R.C. with a direction to consider these documents to be submitted to them by the appellant, and take further action as per the NCTE Regulations,

2014. The appellant is directed to forward to the W.R.C. all the documents submitted in appeal with their letter dt. 23.05.2018 within 15 days of receipt of the orders on the appeal. In the meanwhile, the order of withdrawal shall be kept in abeyance.

NOW THEREFORE, the council hereby remands back the case of College Of Education, Vidyanagari, Motipura, Himatnagar, Gujarat to the WRC, NCTE, for necessary action as indicated above.

6. **AND WHEREAS**, the matter was considered by WRC in its 295th meeting, wherein the committee decided as under: -

The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 12.07.2018 has remanded the case to WRC for further processing the application.

The WRC examined the file and found that the institute has now submitted a staff profile of 1 Principal and 15 faculty members who are approved by the Registrar. However, faculty members from sr. no. 7 to 16 do not have the required NET qualification as per NCTE notification published on 09.06.2017.

Hence, compliance should be submitted within one month failing which the withdrawal orders dt. 18.08.2017 will stand

7. **Accordingly**, A letter was issued to the institution on 17.08.2018 Conveying the decision of 295th WRC Meeting And institution has submitted the reply on 11.04.2019.

8. **AND WHEREAS**, the matter was considered by WRC in its 344th meeting, held on 13th October 2021 wherein the committee decided as under: -

This is a RPRO case and same was remanded back by the Appellate Authority.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the Institution for B.Ed course be restored.

11. **NOW THEREFORE**, the recognition granted to the institution for conducting B.Ed. course has been restored as per decision of the WRC in its 344th meeting and institution is permitted to continue the existing B.Ed. course.
