RESTORATION ORDER

218737 20 218742

WHEREAS, recognition was granted to the institution, namely to RASHTRIYA SHARIRIK SHIKSHAN MAHAVIDYALAYA, BALLAPUR, CHANDRAPUR, MAHARASHTRA, under section 14 (3)A of NCTE Act, 1993 for conducting B.P.Ed. course (50 Intake) vide order No. WRC/5-6/25/2000/6933-39 dated 28.09.2000.

AND WHEREAS, Revised Recognition order was issued to RASHTRIYA SHARIRIK SHIKSHAN MAHAVIDYALAYA, BALLAPUR, CHANDRAPUR, MAHARASHTRA, vide order No. F.No. WRC/OAPW0315/114116/2015/147566-147573 dated 31-05-2015 for B.P.Ed. of Two Years Duration with an annual intake of 100 students (Two basic unit of 50 students) from the academic session 2015-2016.

- 2. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- AND WHEREAS, a Show Cause notice was issued to the institution on 03-10-2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.
- AND WHEREAS, the reply of show cause notice was not submitted by the institution.
- 5. AND WHEREAS, the matter was placed in 292nd Meeting held on May 17-19, & 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 09.08.2016 was issued.

Reply has not been received. As per data available in the file, the institution vide letter dated 17.10.2016 has submitted the staff profile of 5 faculty members, which is not as per Appendix-VII of NCTE Regulations, 2014. The staff profile is not approved by the Registrar.

FDRs for additional Rs.4.00 lakhs in joint account and Building Completion Certificate issued by a Government Engineer not submitted in original.

Hence, Recognition is withdrawn from the next academic session 2018-2019."

- AND WHEREAS, a Withdrawal order was issued to the institution on 02.06.2018.
- 7. AND WHEREAS, the matter was placed in 299th Meeting held on October 30, & November 01, 2018 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made:

"...This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

On perusal of the reply dated 14.09.2018 of the institution, the Committee observed that:-

 The institution has submitted the approved staff list of 1+5 faculty members. However, the faculty members are not appointed as per Appendix-7 of NCTE Regulations, 2014

- Building Completion Certificate duly signed by competent authority not submitted.
- III. FDR for Rs.12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 submitted.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

- AND WHEREAS, the Show Cause Notice was issued to the institution on 14.11.2018 as per decision of WRC, and its reply not received from the institution.
- AND WHEREAS, the matter was placed in 304th Meeting held on April 02-04, 2019 of WRC and the Committee decided that:-

"...The original file of the Institution and appeal order alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time & W.P. No. 6348/2018 were carefully considered by WRC and the following observations were made: -

The Show Cause Notice was issued to the institution on 30/11/2018. The institution has submitted reply dated 30/11/2018 received in WRC office on 30/11/2018

On perusal of the reply of the institution vis-a-vis the consultation of the legal counsel of WRC about the W.P. No. 6348/201 made for further consideration of the case.

The committee observed that the institution has not submitted the following documents:

- The institution has not submitted a letter granting approval for the selection or appointment of faculty, issued by the affiliating body as per NCTE Regulations 2014
- The institution has not submitted Land Use Certificate issued by the competent authority as prescribed in NCTE Regulations.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.P.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- AND WHEREAS, the Withdrawal order was issued to the institution on 15.04,2019.
- AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi.
 W.P. (C) No. 5876/2019 dt. 08.12.2021 the operative part is produced here below:-.
 - "...As the withdrawal order has been set aside by virtue of the present order, the petitioners are entitled to participate in the counselling and admit students for the year 2021-22 and for all subsequent years until and unless as fresh order of withdrawal is passed against the petitioners. The NCTE is directed to reflect the petitioners' status on its website by 13.12.2021 and to communicate the same to the petitioners affiliating University as well as to the concerned State Government within the said period. The NCTE will also issue an order of restoration of recognition to the petitioners within the same period."
 - NOW THEREFORE, recognition dated 28.09.2000 and revised recognition order dt. 31.05.2015 issued to the institution viz RASHTRIYA SHARIRIK SHIKSHAN MAHAVIDYALAYA, BALLAPUR, CHANDRAPUR, MAHARASHTRA for B.P.Ed. course with an annual intake of 100 students (two basic units of 50 students) is hereby restored.
