**REFUSAL ORDER**

Whereas in terms of section 14/15 of the NCTE Act, 1993, to **B.S PUBLIC SCHOOL SAMITI, PLOT NO.- 502, INDRA NAGAR, VILLAGE/TOWN- BHARATPUR, STREET NO.- HEERADAS ROAD , TALUKA/TEHSIL- BHARATPUR , DISTRICT- BHARATPUR, STATE- RAJASTHAN , POST OFFICE-BHARATPUR , PIN CODE - 321001** had submitted an application to the Western Regional Committee of NCTE applied on 20.10.2008 for grant of recognition/permission to **B.S.S.T.C COLLEGE BHARATPUR, KHASRA NO.- 1130, STREET NO. NH11 SEWAR TP BHARATPUR HIGHWAY, VILLAGE- SEWAR , TEHSIL/TALUKA- BHARATPUR , CITY- BHARATPUR , DISTRICT-BHARTAPUR , STATE- RAJASTHAN, PIN CODE-321001** ,for **D.EL.ED** Course of two years.

AND WHEREAS the application was returned back to the application due to the state ban in respect of **D.EL.ED** course .

And whereas, the institution filed a writ petition in the Hon'ble High Court of Judicature for Rajasthan at Jaipur and the Hon'ble High Court **W.P No. 13417/2016** and **13499/2016** order vide order dated **26.09.2016** and **27.09.2016** respectively.

And whereas, the matter was placed before the WRC in its **342<sup>nd</sup>** meeting held on **29<sup>th</sup> -31<sup>st</sup> December 2021** and the committee decided as follows :-

*The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:*

1. The institution has not submitted the reply of Letter of Intent within stipulated time.
2. The institution be directed to submit the following documents :-
  - a. Affidavit on Rs. 100 stamp paper from the President / Secretary of the Management duly notarized giving the details of applications pending with NCTE and also the existing courses being run by the management on the same land where this application is proposed, as per format approved by WRC.
  - b. To submit the proof of submission of initial application to NRC in original, self attested.
  - c. To submit the proof of rejection of initial application by NRC in original, duly self attested
  - d. To submit the proof of payment of processing fee at the time of initial application, self attested (photocopy of DD/ Bank Statement / Certificate from Bank etc)

*In view of the above, the Committee decided that show Cause Notice prior to refusal of recognition be issued to the institution u/s 14/15 (3) (b) of the NCTE Act for D.El.Ed. programme.*

And whereas, the matter was placed before the WRC in its **349<sup>th</sup>** meeting held on **29<sup>th</sup> - 31<sup>st</sup> DECEMBER 2021** and committee decided as follows:-

- The institution has not submitted reply to the SCN dated 4.10.2021 within the stipulated time.

In view of the above, the Committee decided that application of the institution be refused u/s 14/15 (3) (b) of the NCTE Act for D.El.Ed. programme.

Now, therefore, in exercise of the powers vested under section 14/15 (3) (b) of NCTE Act, 1993, the Western Regional Committee hereby refused application of **B.ED** Course of **B.S.S.T.C COLLEGE BHARATPUR, KHASRA NO.- 1130, STREET NO. NH11 SEWAR TP BHARATPUR HIGHWAY, VILLAGE- SEWAR , TEHSIL/TALUKA- BHARATPUR , CITY-BHARATPUR , DISTRICT-BHARTAPUR , STATE- RAJASTHAN, PIN CODE-321001.**

Further, if the institution is not satisfied by the decision, it may prefer an appeal to National Council for Teacher Education, G-7 sector - 10 Dwarka new Delhi - 110075 against this decision under section 18 of NCTE Act 1993 within 60 days of the issue of this letter through online mode, on the NCTE website ncte.gov.in.
