### WITHDRAWAL ORDER

WHEREAS the institution namely, Shri Shankarlal Agrawal Shikshan Mahavidyalaya, Gondia to be run by Loktantra Bahuudeshiya Prachar Sanstha, Gondia, Office-Shankar Bhawan Main Street, Gondia, Maharashtra-441601 submitted application dated 18.06.2005 for grant of recognition to B.Ed. course of one year duration.

- AND WHEREAS, recognition was granted to the institution viz. Shri Shankarlal Agrawal Shikshan Mahavidyalaya, Loktantra Bahuudeshiya Prachar Sanstha, Nangpuramurri, Behind Harikashi Nagar, Gondia, Maharashtra vide Order No.F.WRC/5-6/89/2006/123290 dated 27.09.2006 for B.Ed. course with intake of 100 from the academic session 2006-2007.
- AND WHEREAS, after promulgation of NCTE Regulations, 2014, revised order was 3. issued vide F.No.WRC/APW02005/123290/2015/149549-556 dated 30.07.2015 for conducting B.Ed. programme of two years duration with an annual intake of 50 students (one basic unit of 50 students) from the academic session 2015-2016.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice u/s 17 of NCTE Act, 1993 was issued to the institution dated 15.02.2017.
- AND WHEREAS, the institution did not submit any reply in response to the show cause notice and the matter was considered by the WRC in its 281st meeting held on 19th- 20th September 2017 and the Committee observed as under:

"In order to systemetise the compilation of complete information of all TEPs in the country, the NCTE HQrs New Delhi had asked all institutions to submit the Mandatory Affidavit on the prescribed format. The first such Public Notice was issued on 05.10.2016. Further opportunity was given on 16.06.2017, and the last date for submission was 12.09.2017.

NCTE Delhi also issued Show Cause Notice through PUBLIC NOTICE to submit the Mandatory Affidavit within the specified date. Then, it compiled the list of institutions and identified TEIs which had not complied with the submission of Mandatory Affidavit. The lists were sent to the WRO to reconcile the discrepancies with regard to the address as well as duplication of entries for placing the list to WRC for initiating the process of de-recognition of such institutions. These lists were tabled during the meeting.

The WRC perused the lists as provided by the HQrs as well as the details provided by the WRO.

Thereafter, the WRC decided to issue Show Cause Notice u/s 17 of the NCTE Act for non-compliance of the directions of the NCTE, and why the institution should not be de-recognized. Further directed by the Chairperson WRC, the reply of such notices should be sent on or before 6<sup>th</sup> November 2017, for the 2<sup>nd</sup> list received from after which further necessary action will be taken as per the Regulations."

Accordingly, Show Cause Notice u/s 17 of NCTE Act, 1993 was issued to the institution dated 06.10.2017.

- 6. AND WHEREAS, the institution requested vide letter dated 04.05.2022 (received in WRC, NCTE on 21.05.2022) for de-recognition of their institution for B.Ed. course and return the FDRs maintained towards Endowment and Reserve fund. In the last para of the letter, the institution mentioned that the management proposed the institution building to be constructed at Hari kashi Nagar, NangpuraMurri, Gondia. But they have not started institute on the land, and this address was never institute address, wherein requested to make all communication in future at institution's present address which is at Shankar Bhawan, Main Road, Gondia-441601, Maharashtra.
- 7. **AND WHEREAS**, the matter of request for de-recognition of B.Ed. course from the management of the institution was considered by the WRC in its 366<sup>th</sup> meeting held on 12<sup>th</sup> and 14<sup>th</sup> July, 2022 and the Committee decided as under:

"The original file of the Institution, Visiting Team Report along-with other related documents were carefully examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:

The institution has requested to close the course due to an inadequate number of students

- Requisite documents has also been submitted by the institution for withdrawal of the recognition of B.Ed. course.
- The institution has also not filled up the Performance appraisal Report.

In view of the above, the Committee decided to withdraw the recognition of B.Ed. programme U/S 17 of the NCTE Act 1993."

- 8. **NOW THEREFORE,** recognition granted to the institution viz. Shankarlal Agrawal Shikshan Mahavidyalaya, Loktantra Bahuudeshiya Prachar Sanstha, Nangpuramurri, Behind Harikashi Nagar, Gondia, Maharashtra -441601 for B.Ed. course is hereby withdrawn under section 17 of the NCTE Act 1993 with effect from the end of the academic session next following the date of the communication of the said order.
- The original FDR bearing no.0086334 A/c No.3115078080 dated 22.03.2011 amounting Rs.5,00,000/- (Rupees five lakh) issued by Central Bank of India, Gondia is returned to the institution. original **FDR** bearing no.207798 dated The No.MMDC/47000081/207798 amounting Rs.3,00,000/- (Rupees three lakh) issued by Central India, Gondia has already been returned vide this office F.No.WRC/APW02005/123290/FDR/2011/83960 dated 14.12.2011.
