ORDER

WHEREAS, the institution, namely, **SHIVAJI SHIKSHAN PRASARAK MANDAL, TAKLI (P.D.) TAL. CHALISGAON, AT & PO. TAKALI (P.D.) JALGAON-424101, MAHARASHTRA** was granted recognition by WRC, NCTE for B.Ed. course vide order No.WRC/2-32/ 123097/76/2005/ 6301 dated **09.08.2005**.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW00763/123097/2015/143880, 886,891, 894,897,900 dated **31.05.2015** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255th WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice issued to the institution on 06.03.2017.

4. AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 24.03.2017 received in WRC on 10.04.2017

5. AND WHEREAS, the matter was placed in 316th meeting held on August 27-28 & September 4, 2020 and the Committee decided that:-

"The WRC considered the entire issue in detail and noted that as per NCTE Regulations dated 13.11.2002. Initially institutions were permitted to start the course in a rented-premises with a condition to shift to their own premises within a period of three years from the date of such recognition.

From the Agenda note placed before WRC, it is observed that many institutions have not yet shifted to their own premises neither they have applied to WRC for shifting of premises of their institutions.

The WRC considered the entire issue in detail and decided that Show Cause Notice u/s 17 of the NCTE Act be issued to reply within 30 days to all such institutions which have been permitted or given recognition / permission to run the programme in rented premises and have not yet applied for shifting of their institution.

Further, the WRC also decided that the applications of the institutions who have applied for shifting of premises be examined by office at the earliest and placed before WRC for consideration and decision."

6. AND WHEREAS, Show Cause Notice was issued to the institution on **30.09.2020**

7. AND WHEREAS, in response to the aforesaid show cause notice, reply submitted by the institution vide letter dated 21.10.2020 received in WRC on 28.10.2020.

8. AND WHEREAS, the matter was placed in the 321st meeting held on November 9-11, 2020 and the Committee has decided the following:-

"The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:-

1. Recognition was granted to the institution on 09.08.2005 on rented premises with a condition that to shift the institution in its own premises within a period of three years from the date of issue of recognition order.

2. The institution has not shifted the institution in its own premises till date.
3. Accordingly, Show Cause Noted was issued to the institution on 30.09.2020.
4. The institution has not submitted the reply of the Show Cause Notice till date.

In view of above, the Committee decided that the recognition of B.Ed. programme of the institution be WITHDRAWN under clause 7(15) from the next academic session 2021-21."

9. AND WHEREAS, Withdrawal Order issued to the institution vide order No.WRC/APW00763/123097/322nd/2020/213023-213029 dated 19.12.2020.

10. AND WHEREAS, the institution filed an appeal against the withdrawal order dated 19.12.2020 and the Appellate Authority vide order dated 12.03.2021 remanded back the case to WRC with a direction, "...to consider the reply of the institution to the Show Cause Notice, to be sent to them again by the appellant, and take necessary action as per the NCTE Regulation, 2014. The appellant is directed to forward again to the WRC their reply dt. 21/10/2020 within 15 days of receipt of orders on the appeal."

11. AND WHEREAS, in response to the aforesaid order, reply submitted by the institution vide letter dated 25.03.2021 received in WRC on 25.03.2021.

12. AND WHEREAS, the matter was placed in the 339th WRC meeting held on July 28-30, 2021 and the Committee has decided the following:-

"This is a RPRO case and same was remanded back by the Appellate Authority. The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation were made:

The institution has not submitted the following documents :-

1. Translated version of land documents duly notarized.
2. Non Encumbrance Certificate issued by the Competent Authority
3. Fire Safety Certificate issued by the Competent Authority
4. Building Safety Certificate issued by the Competent Authority
5. Building Disabled Friendly Certificate issued by the Competent Authority
6. Land Possession / Mutation Certificate issued by the Competent Authority
7. Staff list duly approved by the affiliating body for the staff presently working in the institution.
8. Building plan duly approved by the Competent authority for the existing course.
9. Fixed Deposit receipt in original for Rs. 5 lacs and 7 lacs towards Endowment and Reserve fund.

In view of the above, the Committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act for B.Ed. programme."

13. AND WHEREAS, Final Show Cause Notice was issued to the institution on 14.08.2021.

14. AND WHEREAS, in response to the aforesaid final show cause notice, reply submitted by the institution vide letter dated 18.08.2021 & 06.09.2021.

15. AND WHEREAS, the institution had approached the Hon'ble High Court of Delhi at New Delhi vide W.P.(C) No.14035/2021 & CM APPL. 44315/2021 and the Court had passed an order dated **09.12.2021** which is as follows:-

"...5. The petitions are, therefore, allowed, and NCTE is directed to issue orders of restoration of recognition to the petitioners. The petitioners will be permitted to participate in counselling and admit students for the year 2021-22 and for subsequent years, until and unless fresh withdrawal orders are passed against them. The status of the petitioners as recognised institutions will also be reflected on the NCTE's website, and will be communicated by the NCTE to the petitioners' affiliating university as well as to the concerned State Government. The NCTE is directed to comply with these directions within one week."

16. AND WHEREAS, Restoration Order was issued to the institution on **13.12.2021**.
17. AND WHEREAS, institution vide letter dated **29.09.2022** received in WRC on 18.10.2022 has requested for reduction of intake in B.Ed. course from 2 units (100 seats) to 1 unit (50 seats).
18. AND WHEREAS, the matter was placed in 374th meeting (PART-1) held on October 18-19, 2022, and the Committee decided as under: -

"The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Initial recognition was granted to B.Ed. course of one year dated 09.08.2005.
- Revised order was issued for B.Ed. course of two years dated 31.05.2015.
- Recognition for B.Ed. course was withdrawn vide order dated 19.12.2020.
- Recognition restored vide order dated 13.12.2021.
- The proposal submitted by institution on 29.09.2022 for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit).

In view of the above, the Committee decided as under:

The institution be allowed permission for reduction of B.Ed. intake from 100 (two units) to 50 (one basic unit) w.e.f. the commencement of academic session 2022-2023. The Affiliating Body/State Government and others be intimated accordingly."

19. **NOW THEREFORE, permission is hereby granted to SHIVAJI SHIKSHAN PRASARAK MANDAL, TAKLI (P.D.) TAL. CHALISGAON, AT & PO. TAKALI (P.D.) JALGAON-424101, MAHARASHTRA** for reduction of intake in B.Ed. course from an annual intake of 100 students (two units of 50 students each) to **50 students (one unit of 50 students each) w.e.f. the commencement of academic session 2022-2023.**

The terms and conditions mentioned in the revised recognition order issued vide order dated **31.05.2015** shall remain same.


