RESTORATION ORDER

WHEREAS, recognition was granted to the institution, namely to SANT BHAGWAN BABA MED COLLEGE, Bee-Parli Road, kaij, MAHARASHTRA under section 14 (3)A of NCTE Act, 1993 for M.Ed. course (50 Intake) vide WRC/APW06344/125127/123412/140TH/2010/75375-75380 dated 23.02.2011. order

- 2. AND WHEREAS, Revised Recognition order was issued to RENUKAMATA KRUSHI VIKAS PRATISTHAN, PLOT NO. 16/3 CTS. HOUSE NO. 1-6-80/83, SHAHU NAGAR DIST. BEED, MAHARASHTRA vide order No. F.No. APW06344/125127/ 156662-156668 dated 05.12.2015 for M.Ed. of Two Years Duration with an annual intake of 50 students for one basic unit of from the academic session 2015-2016.
- 3. AND WHEREAS, Compliance was not submitted as per regulations 2014.
- 4. AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations,
- 5. AND WHEREAS, a Show Cause notice was issued to the institution on 11.11.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.
- 6. AND WHEREAS, the reply of show cause notice was submitted by the institution.
- 7. AND WHEREAS, the matter was placed in 287th Meeting held on January 30-31, 2018.of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -
 - ...The case file was seen. Show Cause Notice was issued to the institution on 11.11.2016. The institution has not replied so far.

Hence, Recognition is withdrawn from the session 2018-19. FDRs if any, be returned.Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

- AND WHEREAS, the Withdrawal order was issued to the institution on 02.02.2018. 8.
- AND WHEREAS, the institution filed an Appeal to the Council on 28.03.2019 and the Council 9. vide its order dt 23.12.2019 confirm the case to the WRC, NCTE for necessary action.
- AND WHEREAS, the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C)10712/2021 .the operative part is produced here below:-
 - "...The office of WRC has received Hon'ble High Court order. The operative is produced here below:-

As a result of this order, petitioner's status as a recognized institution continues, until and unless a fresh withdrawn order is passed by the NCTE. As a consequence and admit students during such time. The NCTE is directed to issue an order of restoration of recognition within one week. The NCTE will also reflect the status of the petitioner as a recognized institution on its portal and communicate this position to the concerned State Government as well as the affiliating University of the petitioner within the same period."
